### **Free City-Wide Wi-Fi for Vancouver**

As a retired Electronic Warfare officer in Canada's Armed Forces, I am compelled to advise you that the City's decision to implement city-wide, Wi-Fi is extremely ill-advised and fraught with danger because it ignores the growing mountain of global evidence showing the very real dangers of the electromagnetic *pulsed, non-thermal* radiation (EMR) emitted by all of today's wireless radio devices, including Wi-Fi routers, cell phones, cordless phones, cell phone towers, laptop and tablet computers, GPS, Bluetooth, etc. The City of Vancouver must NEVER allow itself to forget the tobacco, asbestos, leaded paint and Thalidomide debacles – all of which the same Health Canada and industry told us were safe! Tragically, government and industry have teamed up, yet again, for their own selfish reasons – at the expense of an unsuspecting and defenseless public!

As Vancouver's Chief Digital Officer, I should think that you have a professional, moral and legal obligation to ensure that you, personally, maintain yourself current with what is happening in other countries of the world, especially with respect to wireless technology -- and with the controversy swirling around it in many countries of the world. Naked corruption is everywhere, just as it was with mankind's earlier debacles. One can easily see it, if only one would look. But because it is your responsibility to ensure that only safe technology is permitted to be used by and/or within City of Vancouver, you absolutely need to know that:

- Wi-Fi transmitters and all of today's wireless radio devices emit what is called: "*low-level, pulsed, non-thermal microwave frequency radiation*" (non-thermal EMR);

- Eminent non-industry scientists internationally say that the human brain is exquisitely sensitive and can detect non-thermal EMR as weak as or one quadril-

lionth of a Watt!

- Non-industry scientists know that a child's brain absorbs five (5) times as much non-thermal EMR as does an adult's brain!
- Contrary to what Health Canada, the CWTA (Cellular Telephone and Wireless Association), cell phone and wireless companies, and electric utilities all tell governments and the public, world-class scientists globally say the only SAFE level of non-thermal radiation is ZERO!
- Health Canada will not even admit that non-thermal EMR is harmful to people!
- Safety Code 6 provides no protection against non-thermal EMR!
- Militaries of the world have known for decades that "pulsed" non-thermal EMR is even more harmful to humans, flora and fauna than is the continuous wave EMR emitted by Microwave ovens!
- Militaries have known since the 1950s that frequencies between 900 MHz and 5 GHz are the most lethal to people, because they penetrate more thoroughly all organ systems of the body. They are especially harmful to the brain, central nervous system and immune system.
- Given the above, it is absolutely inconceivable that Industry Canada has assigned all of today's wireless radio devices to operate on these very same militarily-designated "**lethal**" frequencies! If this isn't a crime against humanity, I don't know what is! Industry Canada's ignorance and/or gross incompetence is putting the lives of all people, flora and fauna in Canada at risk - as never before in our history!
- World-class scientists say there is a direct correlation between the exponential growth in non-thermal EMR-emitting wireless radio devices and the exponential growth all countries have witnessed in today's major illnesses, e.g., all cancers, Leukemia, autism, Alzheimer's, dementia, Parkinson's, ALS, cataracts, heart problems, etc.
- The radio frequency 2.4 GHz, on which Wi-Fi installations, Wi-Fi routers, Zig-Bee transmitters in Smart Meters and all Smart appliances, cordless phones, baby monitors, etc. emit their radiation, is the same frequency on which Microwave ovens cook food and heat liquids! 2.4 GHz is known to be one of the most

harmful frequencies to humans and other life forms! The question must be asked: Why does our government allow industry to use it on us? Is this not genocide?

- Health Canada, the CWTA, the wireless, telecom and electric utility companies don't want you to know that there has never been a single credible peer reviewed scientific study produced anywhere on Earth proving that cell phones are safe for humans to use when held next to the brain! (Cell phone radiation is no different than that of a Wi-Fi router, baby monitor or Smart Meter; although their operating frequencies may vary slightly.) - Nor does today's corrupt government/industrial complex want you to know that, in 2000, the German Research Institute ECOLOG reviewed over 220 peer-reviewed and published papers that found strong indications for the cancer-initiating and cancer-promoting effects of high frequency electromagnetic fields used by mobile telephone technology. - Nor does today's corrupt "complex" want you to know that the U.S. telecom industry's own six-year (1993-1999) \$28.5-million study of cell phones proved they are not safe! - Nor does the "complex" want you to know that, in 2001, the first of at least five major mobile phone companies took out global patents which revealed that cell phones can cause cancers! - It surprises people to learn that just one scientist: Dr. Michael Repacholi was instrumental in establishing the radiation "Exposure Limits" for three (3) agencies! He and Dr. Maria Stuchly established them for Canada; then he moved on, founded ICNIRP (International Commission on Non-Ionizing Radiation Protection) becoming its inaugural Chairman, and established their Exposure Limits. Next he moved to the WHO (World Health Organization) where he led a 10-year, \$250-million International EMF Study to determine safe Exposure Limits for both EMR and EMFs. Utilizing mostly industry scientists, WHO's Exposure Limits were finally determined. Eyebrows shoot skywards and mouths drop when people notice the shocking similarity between the radiation Exposure Limits of Health Canada, ICNIRP, the WHO, IEEE (Institute of Electrical and Elec-

tronics Engineers) and the FCC (Federal Communications Commission)! Dr. Repacholi is now a consultant for industry.

- Today's corrupt government/industrial complex don't want you to know that, in 2008, the European Parliament (28 countries, 500-million people) voted 522 to 16 to urge ministers to bring in stricter Limits for Exposure to radiation from cell phones, cordless phones, Wi-Fi and other devices. New studies then showed that "people who started mobile phone use before the age of 20 had more than five-fold increase in glioma" <http://www.psrast.org/mobileng/mobilstar-teng.htm#chtum>

- Nor does the 'complex' want you to know that, in 2010, the CTIA's (CWTA's counterpart in the USA: Cellular Telecommunications and Internet Association)'s own VP External and State Affairs, K. Dane Snowden, told a public audience in California: "I have not told you once, repeat, not once, that cell phones are safe. - Nor do they want you to know that, in February of 2015, to protect its children, the Government of France created its own national radiation agency – rejecting ICNIRP's obsolete (like Canada's) thermal-based radiation Exposure Limits! As of this year, France has banned Wi-Fi from kindergarten schools across the country. All Wi-Fi routers in other schools must be turned off when not actually in use!

- Health Canada and its Industry friends certainly don't want you to realize that that since 2002, many schools and libraries in England and France, the Bavarian Parliament, the Frankfurt City government, the federal German government, Russia, Poland, the Austrian Medical Association, the Swiss, Belgian and Israeli governments, the L.A. Teachers' Union, The American Academy of Environmental Medicine, The International Society of Environmental Doctors, The Ontario English Catholic Teachers' Association, and many medical associations globally all warn against using wireless technology. (Many references are available.)

- Extremely telling is that the major insurance companies of the world will not insure wireless, mobile phone or electric utility companies against health-related claims attributed to non-thermal EMR! This fact alone should cause Vancouver's mayor and council to rescind their recent decision to allow Telus Corp to install city-wide Wi-Fi! Mayor and council would be well-advised to verify that the City's own municipal insurance would protect them against future lawsuits directed at

them personally by citizens allegedly suffering from the constant pulsed non-thermal EMR to which City-wide Wi-Fi would subject the public on a 24/7/365 basis in perpetuity? If the City's insurance would not protect them, would their personal insurance?

In closing, given all of the above, Ms. Adcock, I strongly urge you to discuss this letter with Vancouver's Mayor and Council. In light of today's hard evidence, the City of Vancouver would be well-advised to rescind its agreement with Telus Corp immediately! Instead of following the City of Surrey, Lemming-like, in their own ill-advised plan to implement City-wide Wi-Fi, the City of Vancouver has a clear opportunity here to demonstrate strong, decisive leadership showing the citizens of Vancouver and Canadians everywhere - and, indeed, the world - that Vancouver, British Columbia's Mayor and Council are: a) technologically enlightened and, b) incorruptible! I am a retired Canadian Armed Forces captain who spent 22 of my 26 years in the military in the arcane fields of Electronic Warfare (EW) and Signals Intelligence (SIGINT). At the zenith of my career, I was the Executive Officer and Operations Officer at one of Canada's largest and most sensitive intelligence-gathering stations, where for two years I personally directed some 200-plus specially-trained radio operators and technicians. In this two-year period, I worked closely with U.S., Canadian and NATO army E.W. units, completed a lengthy NATO army EW officers' course in Anzio, Italy and participated in a major NATO army EW field exercise in the Black Forest of Germany. Earlier in my career, I conducted EW aboard two Canadian warships in exercises with Canadian, U.S. and other international naval allies. My bread and butter for more than 22 years was the radio frequency (RF) spectrum.
