**If Only the Public Understood What Governments Are Doing to Them,
Governments Would Fall!**

British Columbia's preposterous-but-true situation, described below, is no different than what is happening in other jurisdictions across Canada and in all Western countries; only the names change. The architects of today's unprecedented pandemic corruption are paranoid, arrogant, cruel and/or profit-driven individuals in the U.S. Military / Government / Industrial complex who have successfully co-opted their counterparts in Canada and other allied countries since the 1970s. [1]

Health Canada (HC) and industry-paid scientists will not tell you what is behind today's soaring epidemics of autism, ADHD, leukemia, all forms of cancer, Alzheimer's, Parkinson's, ALS and other diseases of the brain, central nervous system and immune system. Yet major militaries and non-industry scientists have known for decades. Why haven't the public been told? [2] [3] [4]

I am a retired Canadian Armed Forces captain who spent 22 of my 26+ years in the 'Forces' in Electronic Warfare (EW) and Signals Intelligence (SIGINT), the former of which included two years in National Defense Headquarters (NDHQ) Ottawa, in the Directorate of Electronic Warfare (DEW). In EW I worked closely with U.S. and NATO armies; attended a major NATO army EW officers' course in Anzio, Italy, and participated in a major NATO army EW field exercise in Germany. I accepted invitations to visit both the U.S. Pentagon and, subsequently, Fort Bragg, North Carolina (which is the USA's principal EW base). Earlier still, I conducted Radio Warfare/EW at sea aboard two Canadian warships. In SIGINT, I was the Executive Officer and Operations Officer for two years at one of Canada's largest and most sensitive radio intelligence-gathering stations, where I employed some 200+ specially-trained radio operators. Throughout this period, I worked closely with the USA's NSA and Britain's GCHQ.

This unthinkable "most evil of all crimes" could not possibly be happening in British Columbia were it not for the cooperation of both our Provincial Health Officer (PHO) and an all-too-obliging news media, the latter of which, tragically for democracy, has become an oligopoly. Both entities have masterfully ensured that the public are unaware of what industry is doing to them – with the complete cooperation of naïve, gullible, pathetically co-opted and revenue-starved governments everywhere! [5] [6] [7] How else can one explain why the public hasn't been allowed to know that:

- For literally decades, distinguished non-industry scientists from around the world have been warning world governments and international regulatory agencies – including the WHO (World Health Organization) - about the harmful effects humans and other life forms experience when exposed chronically to man-made radiation (emitted by wireless devices, and conventional 60 Hz alternating current (A/C) and everything that uses electricity; see below) on a 24/7/365 day basis? [8] [9] [10]

- In 2015, at least 215 world-class scientists and health researchers from 40 countries signed the “International EMF Scientists Appeal” urging the Secretary General of the United Nations, all U.N.-member nations, and the Director General of the WHO to: *“protect mankind and wildlife from the dangers of EMF and wireless technology!”* [11]
- In 2015, HC admitted that studies do show harm below SC6 levels etc.; also, it was alleged that HC is behind other countries in recognizing the dangers of wireless radiation! [12][13]
- In 2015, the Government of France banned Wi-Fi from all kindergartens across the entire country and directed ‘higher’ schools to ensure Wi-Fi is switched off when not actually in use! [14]
- In 2014, Fifty-three scientists from 18 countries condemned SC6 and called on HC to intervene to: *“Help avoid an emerging health crisis!”* [15]
SC6 is supposed to protect Canadians from threats to our health, which includes both the radiation from all consumer wireless products, as well as wireless Smart Meters and the emerging family of new wireless ‘Smart’ appliances; and the harmful electric and magnetic fields (EMF) which are present with all A/C electricity (see below).
- In 2014, Twenty-two Canadian doctors openly condemned SC6 and called for HC to *“protect Canadians from Radiofrequency Radiation Exposure!”* [16] [17] [18]

Man-made Radiation

In simple terms, man-made radiation is called “EMF” for the Electric and/or Magnetic Fields of which the radiation or ‘energy’ is comprised. EMFs come in two basic forms:

- 1) Radio Frequency (RF)-Microwave (M/W) Radiation or RF-M/W EMF - Is the microwave radiation emitted by today’s wireless consumer devices – even baby monitors, as well as Smart Meters and the entire emerging family of new wireless ‘Smart’ appliances. Although electric utilities don’t tell the public, they expect homes of tomorrow will each have 15-or-so ‘Smart’ appliances, all of which will be controlled by a Smart Meter’s 2nd microwave transmitter, called the “ZigBee.” The ZigBee and all ‘Smart’ appliances will operate (i.e., emit their RF-M/W EMF ‘radiation’) on the same microwave oven frequency of 2.4 GHz! *(This statement alone means that each and every home is expected to have 17-or-more harmful microwave transmitters – 15 of which will emit their invisible, undetectable RF-M/W EMF inside every unsuspecting and defenseless household! The remaining two transmitters are inside every home’s Smart Meter!)* [19]
- 2) Extremely Low Frequency or ELF EMF – refers to the Electric and Magnetic Fields that accompany all A/C electricity, e.g., high voltage transmission and distribution lines, electric power sub-stations, power transformers, household 60 Hz electricity, all electrical appliances, power tools, machinery etc. Leading non-industry scientists

around the world have known since 1979 that even very weak magnetic fields in homes causes leukemia in children. [20] Numerous studies from around the world show EMFs cause various cancers and other diseases, [21] and there is copious evidence showing the systemic corruption within the electric power industry, HC and the WHO itself! [22] [23] [24]

Electro-Hyper-Sensitivity or “EHS”

Was first discovered by German scientists in 1932, when it was called radiation sickness. Experts now estimate that anywhere from 3% to more than 10% of the entire global population is seriously intolerant of any man-made radiation. In Sweden EHS is classified as a physical impairment and a disability for which accommodation must be made by employers.

With respect to both RF and ELF EMFs, the industry-affiliated scientists are employed in: a) Health Canada’s radiation protection section; b) in Industry Canada (see below); in electric power utilities; and, c) in the R. Samuel McLaughlin Centre for Population Risk Assessment! All of them refuse to acknowledge – and have for decades - that the low-intensity, pulsed NON-thermal microwave radiation emitted by wireless consumer products, as well as Smart Meters and their associated ‘Smart’ ‘Appliances, is harmful to humans and other life forms. As one, they say that if radiation does not heat the skin it cannot be harmful! Similarly, none of them will acknowledge that there is such a debilitating condition known as EHS! Nor will B.C.’s PHO!

Industry Canada is equally culpable, for it was/is they who: a) have permitted the wireless and telecom Industry – and still do - to introduce and sell to governments and the public a seemingly endless array of wireless consumer products; b) enabled the above wireless products to be licensed for use in Canada without first ensuring that each underwent independent testing to prove it is safe to be used by, on and around people of all ages, of all sizes and of all levels of wellness on a continuous 24/7/365 day basis in perpetuity; c) assigned all of the above consumer wireless products to emit their harmful RF EMF radiation on frequencies known to be the most harmful/lethal to humans – those within the band of 900 MHz to 5 GHz! For example: cell phones typically use 900 MHz; cell phone towers - 1900 MHz; baby monitors, cordless phones, Wi-Fi routers, Bluetooth, Smart Meters (i.e., the “ZigBee” transmitter), all ‘Smart’ appliances, etc. “use” (i.e., emit their radiation on) the microwave oven frequency of 2.4 GHz! Newer Wi-Fi routers are assigned a second frequency which is in the 5 GHz band. It is known that these same frequencies have been used by Soviet and U.S. militaries as weapons since the 1950s! [25] [26] [27] [28] [29]

Because Smart Meters were provincially legislated (in 2010), B.C.’s PHO could then have – and should have – prevented electric utilities in British Columbia from using the wireless radio option. Instead, he should have insisted that they use a safe option, such as fiber-optic cable, which is known to be perfectly safe, far more secure, infinitely more dependable and robust. But he didn’t! His dereliction of duty at that time (which was to protect the public), has resulted in communities in B.C. now being blanketed with invisible, ever-thickening clouds of toxic microwave radiation 24/7/365 days - in

perpetuity! BC's PHO is also guilty for not insisting that wireless Smart Meters and all wireless 'Smart' appliances must first undergo independent testing to ensure each is safe to be used by, on and around people – of all ages, sizes, and degrees of wellness – on a 24/7/365 day basis in perpetuity! Once again, he failed the people of B.C.! Also, Industry Canada is once again guilty for having allowed electric utilities to use 910 MHz and 2.4 GHz, both of which are known to be amongst the most harmful radio frequencies to humans and wildlife! This crime continues!

Others can decide whether or not BC's PHO is 'corrupt.' But if he is not, he surely is guilty of gross incompetence, dereliction of his duties, and of forsaking his oath as a physician - to protect the public. Since he became PHO, in 1999, instead of protecting British Columbians from low intensity RF EMFs and ELF EMFs and protecting those who suffer from EHS, history shows that he has been but a puppet of both B.C.'s provincial government and of HC. With respect to HC, B.C.'s PHO historically has seen fit to simply adopt, endorse, defend and champion their duplicitous rhetoric - that wireless technology is safe and that SC6 protects Canadians – which non-industry scientists know is absolute nonsense! Clearly he still does not know that HC's own Dr. James McNamee admitted to a Quebec Superior Court judge in 2013 that SC6 does NOT protect against NON-thermal radiation (which is the kind of radiation emitted by all of today's wireless devices - including Smart Meters and all 'Smart' appliances)! [30]

In fairness, most people in the consumer retail wireless and telecom Industry can claim to be ignorant of the dark side of this science; therefore, one must allow that that their national lobby group, the Canadian Wireless and Telecommunications Association (CWTA) is not now - and possibly never has been corrupt, per se – but they certainly have been duped by the corrupt federal authorities named above, and by B.C.'s PHO, into believing that wireless technology is both safe and benign.

The BC Government – and ALL governments in the world - must wake up and realize that an uncontrolled, overly-zealous Industry are aggressively pursuing and finding new applications for wireless technology – and must be stopped immediately! Two frightening examples: 1) according to Canada's W5's recent TV program, driverless vehicles will be able to 'sense' any object within 600 feet of the vehicle - in all directions! To do this means that all such vehicles must have microwave transmitters fitted around the vehicle which will irradiate (emit their low-intensity pulsed RF EMF radiation upon) every person and living thing within a radius of 600 feet of every driverless vehicle! This is sheer madness! 2) An earlier news announcement said that Google is preparing to launch some 220,000 high-altitude balloons that will make possible Wi-Fi from space access to something like 96% of at least North America! This means that 96% of North Americans will be irradiated 24/7/365 in perpetuity with yet another layer of harmful low-intensity, pulsed microwave radiation (RF-M/W EMF)! Scientists know that EMF is cumulative; it all adds up, from each and every device! Because governments remain ignorant of this technology (or are themselves corrupt), there is no brake on what an unquenchably greedy Industry will do! It is not an exaggeration to say that the future of mankind is at stake! This amounts to certain genocide! National governments simply

must act!

In summary, from B.C.'s perspective, corrupt scientists in HC, Industry Canada, R. Samuel McLaughlin Center for Population Risk Assessment, and in the electric power utility industry are the principal masterminds of this most heinous crime in Canada's history - ever! CWTA and the news media, sadly, are both nothing more than gullible, naïve, profit-driven but technologically ignorant victims of this same crime - as are the general public and governments everywhere! BC's PHO, if not corrupt, certainly is guilty of gross negligence and/or dereliction of duty for making no attempt to protect British Columbians from today's RF and ELF EMF radiation; nor has he protected those suffering from EHS! He has deliberately chosen to ignore the literally thousands of non-industry scientists' and, separately, thousands of military studies from around the world that prove that both RF and ELF EMFs are harmful to humans and other life forms. Also, he has consistently ignored all of the many attempts I and other informed people have made to educate him over these past many years. He has made it abundantly clear that he listens only to the B.C. Government and to Health Canada.

Given today's reality, B.C.'s historical deference to Industry Canada on matters dealing with the siting of radio transmitting towers and a transmitter's effective radiated power should unilaterally be terminated immediately! Provincial governments need to realize that SC6 does not now - and never was intended to - apply to the provinces; it is the provinces who (sadly) chose to adopt SC6! It is time for the Government of BC to assert itself in order to protect its citizens from both RF and ELF EMFs, and it must also formally recognize EHS and ensure that those who suffer from it are recognized in the workplace and afforded every reasonable accommodation, as is now the case in Sweden. As quickly as is practicable, B.C.'s government must also:

- Replace the current PHO with an incorruptible, competent medical doctor who has – or will soon acquire - some education, qualifications or expertise in low-intensity, pulsed, non-thermal non-ionizing radiation, both RF-M/W and ELF EMF. A new PHO should be expected to quickly establish good communications with leading non-industry EMF authorities in Europe and North America, and heed what they have long known and are now attempting to do to protect their citizens. Certainly, a new PHO would strongly encourage the BC Government to recognize EHS and enact legislation that would properly and humanely address the legitimate needs of those affected.
- direct electric utilities to halt any further installations of Smart Meters;
- direct electric utilities to replace Smart Meters already installed with safe and benign analogue meters – solely at the utilities' expense;
- direct electric utilities to return all monies extracted (extorted) from customers who wanted only to keep their safe/benign analogue meters, and those who wanted the microwave transmitter (1 of 2) switched off in their imposed wireless Smart Meter;

- direct wireless and telecom companies to remove cell phone towers from all provincial buildings and properties, and to re-locate them to distances in accordance with the BioInitiative Report 2012 [2];
- inform and explain to privately-run kindergartens, places of learning, hospitals, correctional facilities, senior's homes, privately-owned buildings and property throughout the province of the provincial government's actions, advising them of the dangers of RF EMF and ELF EMF, and recommend to them that any/all Wi-Fi should be removed and replaced with wired Internet access.
- effect unambiguous legislation that identifies BCUC (utilities commission) as the sole authority – free from any interference or influence from government – responsible for licensing, regulating and controlling the operations of all companies providing and/or delivering electricity within or to the province of BC. No longer should citizens of B.C. be forced to endure the reprehensibly undemocratic and uncivilized behaviour of today's arrogant, bullying, uncaring, monopolistic electric utilities.

One cannot exaggerate today's preposterous but very real predicament! If mankind and wildlife are to be saved, governments must heed non-industry scientists and implement the needed changes in accordance with what the consensus of honest scientists say. While the costs will surely be enormous, they will never be less than they are today! There is no other option,
