The BC Safety Authority received your request for access to information under the *Freedom of Information and Protection of Privacy Act* (the Act) on August 25, 2014.

According to your application, you requested the records related to the following electrical incidents:

- Cloverdale's Vault Restaurant, 5764 176th Street, Cloverdale, BC on October 2012
- Rosalinda's Filipino Restaurant, 2810 33rd Street, Vernon, BC on January 13, 2013
- 3440 Mierau Street, Abbotsford, BC on November 17, 2013

Attached is the requested document for 2810 33rd Street, Vernon. Please note BC Safety Authority did not investigate the incidents at 5764 176th Street, Cloverdale and 3440 Mierau Street, Abbotsford and therefore we have no records in our possession related to these two incidents. Cloverdale is within the municipal boundaries of Surrey and as previously advised Surrey does not fall under BCSA's jurisdiction. For your reference, I have attached a card showing which municipalities are outside BCSA's jurisdiction for Permits and Inspections.



Executive Summary:

On January 14 2013, at 2810 33rd Street, Vernon B.C. at 13:30 hours, there was an electrical fire in the service equipment at Rosalinda's Family Restaurant. There were no reported injuries. The electrical fire destroyed a B.C. Hydro meter and the incoming electrical services to the meter. An adjacent 240 volt service was also damaged, and both services have been disconnected by BC Hydro. The fire was caused water leaking into the service conduit which caused a short circuit.

Full Description of Incident:

On January 14 2013, at 2810 33rd Street, Vernon B.C., at 13:30 hours, there was an electrical fire in the service equipment at Rosalinda's Family Restaurant. There were no reported injuries. The electrical fire destroyed a B.C. Hydro meter and the incoming electrical services to the meter. An adjacent 100 amp 240 volt service was also damaged, both services have been disconnected by BC Hydro. The fire was caused by water leaking into the service conduit which caused a short circuit.

There were two services in the building. One 100 amp 240 V single phase and the other a 60 amp 208 volt three phase. The only load connected to the three phase system was a commercial dough mixer which was not connected at the time of the incident. Both service meter bases were located inside the restaurant, on an outside wall behind the service counter.

A short circuit from water leaking into the service conduit, at the entrance to the meter base occurred causing the incident.

Summary of Damages, Injuries, Fatalities:

A 60 amp 208 volt service conduit, conductors and meter base were totally destroyed. An adjacent 100 amp 240 volt service was damaged, both services have been disconnected by BC Hydro.

There were no reported injuries due to this incident.






Cause Summary:
