Nurses Are 'Canaries in a Coal Mine'!

Executive Summary

Because this letter exposes what many people might think is simply too preposterous, CRNBC is urged to first learn what some of the world's top radiation scientists have said publicly about today's ubiquitous and terrifying radiation issue, before reading this scathing indictment of the Government of Canada's corrupt agencies: Health Canada and, what previously was known as, Industry Canada. This letter also exposes the inconceivable inability of ANY jurisdiction in Canada to protect its citizens from corrupt governments! It also exposes the failings of Canada's own deplorably unaccountable mainstream news media!

The Biolnitiative 2012 Report, which had 29 authors (including 21 PhDs and 10 medical experts - from 10 different countries) is considered to be the most respected, independent, authoritative science-based report in the world! [1] It concluded – six years ago – that **non-thermal** radiation (which Health Canada, the USA, UK, Australia and New Zealand all deny publicly even exists) is a "Known Carcinogen" – it **CAUSES cancer!** It also stated that Health Canada's Safety Code 6 'safe' radiation Exposure Limits were 3-6 million times too high! Also, Canada's distinguished epidemiologist, Dr. Anthony Miller, Professor Emeritus at the Dalla Lana School of Public Health of the University of Toronto, and Sweden's Dr. Lennart Hardell, the world's foremost authority on cell phone radiation and brain tumors, both say that radio frequency radiation (which is **non-thermal**) is a "Group 1 carcinogen to humans"! It **CAUSES cancer**! [2] CRNBC are also urged to acquaint themselves with the USA's Physicians for Safe Technology website, which is also very informative. [3]

CRNBC members will recall that Health Canada told us for many years that Thalidomide, tobacco, asbestos, lead, etc. were all safe! History has proven otherwise. Today, the same Health Canada is at it again, only this time its 'Radiation Protection Bureau' is guilty of perpetrating the most heartless, cruel and pernicious crime – ever in human history! Although every man, woman and child in Canada is a victim of this ongoing crime – those most in danger are nurses, healthcare practitioners and patients! Each is the proverbial 'canary in a coal mine' (See below)!

Some 50-or-more years ago, Health Canada made the decision to become an integral member of what was then a fledgling but corrupt US Military-Industrial-Complex (M-I-C), which has since experienced astonishing – and frightening - growth, to the extent that it now has 'captured' national governments and exerts significant influence over both international regulatory agencies, i.e., the WHO (World Health Organization) and ICNIRP (International Commission on Non-Ionizing Radiation Protection) – as well as Health Canada and what used to be called Industry Canada! In 1979, Health Canada

produced its first Safety Code 6, which was cleverly-crafted and deliberately duplicitous! Instead of protecting the public against **non-thermal** radiation, Safety Code 6 made it possible for electric power utilities and wireless and telecom companies to exploit extremely profitable technologies, all of which emit **cancer-CAUSING non-thermal** radiation – which they continue to do today!

In this context, there are two kinds of radiation: "*thermal*" – which is invisible and heats the skin; and, "*non-thermal*" – which is also invisible, but which the human body cannot detect and is known to **CAUSE cancer**! Mainstream news media, by their silence, have prevented CRNBC – and Canada's entire medical community - from knowing that common everyday 60 Hz electricity, when current is flowing, emits hazardous **cancer**-**CAUSING** *non-thermal* electric and magnetic fields. So too does each and every wireless radio product / device / gadget - but each is obscenely profitable, to both industry and governments! Knowing this, one cannot think of a more 'toxic' or 'dangerous' environment in which to work, than in a major hospital, e.g. Vancouver General, BC Children's, and BC Women's, given their extraordinary dependency on electricity and wireless electronic equipment, each item of which emits hazardous **cancer-CAUSING** *non-thermal* radiation!

On behalf of its members, CRNBC has an obligation to find out why there are **cancer-CAUSING** Wi-Fi routers, Bluetooth devices, cell phones, cordless phones, tablet and laptop computers, wireless keyboards and mice, etc. in British Columbia's **cancer** clinics, hospitals, nursing homes, schools etc.? The answer? Because BC does not have a single health official with the requisite expertise in **non-thermal** radiation to stop Telus or other utilities from installing their dangerous, highly profitable, wireless technologies! Nor does BC have anyone with the requisite expertise to prevent BC Hydro or Fortis erecting their overhead power lines, power transformers, substations etc. dangerously close to schools, homes, hospitals, residential areas, etc.! Those lacking such expertise include BC's PHO (the incumbent and her predecessor), BC's Centre for Disease Control and all five Regional Health Authorities!

Unforgivably, mainstream news media has not allowed CRNBC - or Canada's entire medical community - to know that:

- Currently, at least 235 world-class scientists from 41 countries have signed the "International *(radiation)* Scientists Appeal (my emphasis)." Specifically addressed to the Secretary General of the UN, to all 193 UN-member countries and to the Director General of the WHO, they urged all governments to: "Protect Mankind and Wildlife From *non-thermal* radiation and wireless technology" (my emphasis)!
- In 2017, at least 180 scientists from 35 countries demanded that all governments place a moratorium on 5G (fifth generation) technology until it is proven to be safe – by independent, qualified professionals – having no ties to industry;

- In 2016, the latest US Centre for Disease Control survey showed that 1 in 36 US children was autistic 1 in 28 boys!
- Non-industry scientists say that this *non-thermal* radiation **CAUSES** autism, ADHD, leukemia, breast **cancer**, brain tumors, thyroid **cancer** and most other **cancer**s, Parkinson's, Alzheimer's, ALS, suicides, miscarriages, depression, memory problems, cardiac problems, etc. Tragically, once again, greed leads to corruption ... the victims of which are the innocent, unsuspecting, trusting and defenceless public.

Introduction

Informed people know that nurses, especially those who work in large specialized and tertiary care medical hospitals, work in some of the 'dirtiest' and 'most toxic' biological environments known to man - because of the extraordinary number and assortment of technologies found in these large, complex healthcare facilities, many technologies of which are unique to the healthcare field. Ranging from basic copy machines, paper shredders, adding machines, battery rechargers, hand dryers, vacuum cleaners, TV sets, video monitors, etc. (all of which simply plug into standard 60 Hz wall outlets) to state-of-the-art MIS and telecommunications systems and a host of sophisticated imaging, diagnostic, monitoring and treatment equipment, these technologies all emit invisible but **cancer-CAUSING non-thermal** radiation (explained below).

(Note: Industry does not want the public to know this, but *anything* in which 60 Hz alternating (A/C) electrical current is flowing emits **cancer-CAUSING** *non-thermal* Extremely Low Frequency (ELF), which is also called "Powerline Frequency (60 Hz)" radiation, in the form of electric and magnetic fields (EMF)s. Similarly, all wireless radio frequency (RF) technologies emit "*pulsed*" **cancer-CAUSING** *non-thermal* electro-

magnetic radiation (EMR). This **cancer-CAUSING** radiation is invisible, silent, odorless and tasteless, yet today it is literally everywhere, and it is cumulative – it all adds up, creating an ever-thickening but invisible blanket of what scientists today call "Electrosmog"! There are two basic kinds of non-ionizing radiation: 1) "*thermal*" – that which the body can sense; and, 2) "*non-thermal*" – that which the body cannot detect or sense.)

Given that nurses are the ultimate selfless care-givers and the virtual glue that holds every healthcare system in place, it is particularly upsetting – and disgraceful - to realize that Canada's governments (all of them) have allowed themselves to be 'captured' by the electric power and wireless / telecom industries, neither of which is at all concerned about the public's health and safety! Their sole focus is on the corporate bottom line – on making a profit! Neither has a conscience or a moral compass! Innocent, unsuspecting nurses are easily the most vulnerable of all professions due to their places of employment. Canada's federal government – both parties - especially ministers of health, public safety, and environment have all been – and still are – disgracefully derelict in their duties, because they remain stubbornly deaf and 'blind' to what industry is doing to Canada's people – nurses in particular!

Nurses should be shocked and outraged to learn that there is not one senior health care official in B.C. – or anywhere in Canada - with the requisite expertise to enable them to formally challenge or question Health Canada's corrupt EMF / EMR scientists and/or its globally vilified Safety Code 6! Yet, it is Safety Code 6 that allows electric power utilities and wireless / telecom companies – with their **cancer-CAUSING non-thermal** radiating technologies - to continue harming the unsuspecting public and causing millions of premature deaths!

Nor does B.C. have a single senior health official with the requisite expertise to enable them to challenge, let alone prevent, B.C. Hydro, Fortis B.C., Telus or any other utility in the province, from installing / building / doing whatever they want, wherever they want – e.g., erecting cell phone towers too close to schools, hospitals, residential areas, etc., constructing substations too close to schools, homes, etc.; installing Wi-Fi systems in **cancer clinics**, hospitals, schools, etc.!

Knowing the above, it is downright frightening and preposterous to know that the BC government, in 2011, signed a ten-year, \$100-million/year (potentially a \$1-Billion) contract with Telus, for the latter to upgrade B.C.'s telecommunications throughout the province – both hard-wired and wireless. With no EMR / EMF-qualified health official anywhere in the province to monitor and/or supervise Telus, the latter was able – and continues to this day - to install extremely profitable but **cancer-CAUSING** wireless technology virtually anywhere they want throughout the province – including throughout all five (5) BC Regional Health Authorities, etc.! Even in **cancer clinics**! [1] [2] Simply unbelievable!

Irrefutable Evidence of Corruption Causing Harm on a Gobal Scale

- 2018. In addition to the literally thousands of independent, peer-reviewed studies from around the world which concluded that *non-thermal* radiation is harmful to humans and all forms of life, as of July, 2018, at least 235 EMF scientists from 41 countries have signed the "*International EMF Scientists Appeal*" (originally signed in 2015 by 190 scientists) calling for all world governments to: "*Protect Mankind and Wildlife from Electromagnetic Radiation and Wireless Technology*"! [3]
- In 2017, more than 180 scientists and doctors from 35 countries demanded that all governments place a moratorium on "5G" (fifth generation) wireless technology, which telecom companies are aggressively testing and installing in unsuspecting cities in most Western countries. Once again, no government – ANYWHERE – has required telecom companies to conduct independent testing (by qualified EMR experts - having no ties whatsoever to industry) to ensure that this new millimetre technology is biologically safe to all humans and other forms of life! [4] [5]
- In 2012, the BioInitiative Report (which has become the unofficial 'Bible' for nonindustry scientists around the world) classified Powerline EMFs (60 Hz) and RF EMR both "Human Carcinogens" i.e., both CAUSE cancer! [2]
- In 2012, the International Doctors Appeal, which reminded readers of the earlier 2002 Freiburg Appeal, again called on the public, politicians and health officials to heed their strong warnings about the dangers of wireless radiation. The Freiburg Appeal was signed by more than 1,000 physicians and more than 36,000 people worldwide! [6]
- In 1971, long before wireless technology appeared in North America, then U.S. President Richard Nixon's own Radiation Advisory Panel warned him that the entire U.S. population might already be biologically at risk (from non-thermal radiation – my comment), and those most at risk might be all future generations! [7]
- In 1968, then U.S. President Lyndon B. Johnson, in his State of the Union Address, promised: "To protect the American people from 'the hazardous radiation emitted by TV sets and other electronic equipment'"! [8]

North America's Complicit Mainstream News Media

Disgracefully, mainstream media continues to remain largely silent on this, what has become, the worst, most pernicious crime against humanity - in human history - caused by the frighteningly powerful and corrupt US Military-Industrial-Complex, whose interests are: 1) ensure that the USA remains the world's only super-power (meaning that the US Military must always have the most advanced technology available in its weapons and telecommunication systems! 2) support and facilitate the electronics, computer and telecom industries on which the US Military depends; and, 3) get the world (i.e., the WHO and ICNIRP) to adopt the USA's outrageously high – **thermal-only** - 'safe' radiation Exposure Limits!

Had Canada a truly "Free Press," the following could not have happened:

- Just one corrupt scientist, the now infamous Dr. Michael Repacholi, established the supposedly 'safe' Exposure Limits for people exposed to RF EMR - not just for Health Canada's Safety Code 6 (which he did in 1979), but for both international regulatory agencies as well, i.e., ICNIRP (International Commission on Non-Ionizing Radiation) - which Repacholi helped to create (becoming its Chairman and for which he is now Chairman Emeritus), and for the WHO (World Health Organization)! When he retired from the WHO, in 2006, Repacholi's protégé, Dr. Emilie van Deventer, an electrical engineer, whom he recruited in 2000, succeeded him! [9]
- From 1966 until 2015, Health Canada's Safety Code 6 'safe' Exposure Limits for people exposed to RF EMR, like all Western countries, were about 3-6 million times too high! [2] Even though Health Canada lowered Safety Code 6 'safe' Exposure Limits some 66 times, in 2015, experts say they are still far too high! Even today, Health Canada's website [10] deliberately misleads the public into thinking that Safety Code 6 protects them against both thermal and *non-thermal* EMR on all frequencies, when, in fact, Health Canada's own lead author of Safety Code 6, Dr. James McNamee, admitted in a Quebec Superior Court in 2013 that it protects against non-thermal EMR ONLY on frequencies BELOW 100 kHz (kilo Hertz). Readers should note that all of today's wireless products emit their hazardous radiation on frequencies that are much higher between 3 MHz (mega or millions of Hz) to 300 GHz! (giga or billions of Hz)![11]
- Health Canada, ICNIRP and the WHO like the U.S. Military all recognize ONLY the thermal effects of radiation! As one, they stubbornly ignore the US Military's own studies and the literally many thousands of independent, peer-reviewed scientific studies conducted over the past 60 years, which show that there are very real, hazardous non-thermal biological effects to EMR, both ELF and RF! [12] (Note: This despicable, heartless and deliberate travesty enables industry to manufacture and sell cancer-CAUSING 'smart' meters and all of today's obscenely profitable consumer wireless RF products, which otherwise would be banned from this planet! Safety Code 6 also makes it possible for telecom companies to erect cell towers dangerously close to schools, hospitals, residential neighborhoods, etc.!)
- In terms of Powerline Frequency (60 Hz) magnetic field radiation, Health Canada, like the USA, says that levels now found in homes etc. are safe and that the public should not be concerned. Disgracefully, Health Canada publicly endorses and

recommends to other nations that they too follow ICNIRP's outrageously high 'safe' magnetic field recommended limits of **2,000 mG** (milliGauss) for the Public, and **10,000 mG** for Occupations! So does the corrupt WHO! Whereas, independent world-class scientists say that magnetic fields should be not more than **1 mG!** (*Note: This enormous discrepancy makes it possible for electric utilities to erect their power lines, substations, power transformers, etc. dangerously close to schools, hospitals, residential neighborhoods, homes, etc., which saves the utilities, nationally, literally hundreds of millions if not billions of dollars they would otherwise have to spend to purchase the additional land needed for them to provide the public with larger (safer) buffer zones separating them from dangerous utility electrical infrastructure). [13]*

- Health Canada, like the U.S. Military and ICNIRP, refuses to recognize that a condition known as electro-hypersensitivity (EHS) even exists! First reported in 1932 by German scientists, EHS was then called 'microwave sickness.' It is conservatively estimated that more than three percent (3%) of the world's entire population are sensitive to and even seriously impaired by any form of EMR, regardless of how weak the signal(s) might be! The world's first celebrity to admit that she suffers from EHS is Dr. Gro Harlem Brundtland, MD, MPH (Harvard U.), former Director General of the WHO and, before that, three-time Prime Minister of Norway!
- Independent, world-class EMR / EMF scientists say that *non-thermal* EMFs and "pulsed" *non-thermal* RF EMR CAUSE most, if not all, of today's disease epidemics (e.g., autism, ADHD, all forms of cancer, including leukemia, Alzheimer's, Parkinson's, ALS, suicides, depression, miscarriages, memory problems, cardiac problems, etc.) [2]
- <u>Ultrasound</u> In 2015, women, especially pregnant women, should be told that, "Unknown to Western scientists, the hazards of ultrasound have been confirmed in China since the late 1980s." Critics suspect that ultrasound scans contribute to the rise of, if not cause, autism! [14]
- <u>CT Scans</u> Breast Cancer In 2015, Consumer Report's, January edition, stated that CT scans **CAUSE** an estimated 29,000 new cases of **cancer** per year in the USA, of which 15,000 people will die! [15]
- <u>Mammograms</u> breast cancer In 2012, it was said that the radiation to which a patient is exposed in just one mammogram can equal that of 1,000 chest X-rays!

- <u>Miscarriages</u> Women exposed to magnetic fields of just 2.5 mG for only 14 minutes a day - are more likely to have a miscarriage; whereas women normally

exposed to magnetic fields of **16 mG**, or more, experience at least six times the number of miscarriages! [2] [17]

- <u>Cell Phones</u> In 2010, the US Cellular Telephone Industry Association (CTIA) successfully sued the City of San Francisco (threatening to cancel all of the cell phone industry's conventions scheduled to be held in that city) to block them requiring cell phone retailers to display cell phone radiation information, warning customers not to hold phones close to their head, not to carry phones in pockets, bras, etc.! [18] Five years later, in 2015, the CTIA also sued unsuccessfully the City of Berkeley, California, attempting to block that city's ordinance, which required cell phone providers to post RF warnings in their stores to alert the public not to hold cell phones against their head, in pockets, bras etc. [19] CTIA's subsequent attempt, in 2016, to have a higher court overturn that decision also failed!
- <u>Cell Phone Towers</u> In 2006, a ten year study (1996-2006) was completed in Brazil's 3rd largest city, Belo Horizonte, in which were found more than **7,000 cancer** deaths attributed to cell phone tower radiation! [20]
- <u>Wi-Fi Routers, Wi-Fi & Wi-MAX Zones, Wi-Fi from Space</u> Technologically ignorant governments have allowed industry to install Wi-Fi anywhere and, seemingly, everywhere: entire homes, work places, schools, shopping centres, buses, trains, ferries, airplanes, cruise ships, communities, cities, etc. are now completely bathed in 2.4 GHz or, with newer technology, simultaneously with both 2.5 GHz and 5 GHz radiation! Soon the entire North American continent and even planet Earth itself will be bathed with invisible radiation on what are (untested for biological safety to humans) 5G frequencies, i.e., 12-18 GHz, 27-40 GHz and 40-75 GHz bands from non-geostationary satellite systems, e.g., SpaceX's already authorized 4,425 non-geostationary satellites, Oneweb's planned 1,980 satellites, Telesat Canada's 15 satellites with others to follow from Space Norway, SES' 03b Networks, Iridium, SOM1101, Google and Boeing all to provide the unsuspecting, trusting and defenceless public with broadband Internet access from space! [21] [22]
- <u>AM / FM Radio and TV Towers</u> can CAUSE cancer! In 2011, Italy's Supreme Court ordered Vatican Radio to compensate residents for illnesses (cancers) citizens attributed to the EMR emitted by radio towers! [23] [24] [25]

Conclusion

Now that the CRNBC has some appreciation of today's preposterously dangerous situation, in which 'captured' governments everywhere have allowed – and still do - electric power utilities and wireless / telecom companies to exploit governments' and the public's ignorance of **cancer-CAUSING** *non-thermal* EMFs and EMR, it is your duty to

act NOW in order to protect your members. In doing so, you will also be protecting the equally unsuspecting and defenseless public. Your brave public actions will certainly awaken every other jurisdiction in Canada, especially Canada's entire medical and legal communities, all of whom will take action based on CRNBC's leadership! Other countries, once they learn of what you have done, will take similar action to protect their citizens! Your members could not be more proud of CRNBC and its leaders!

Recommendations

Now that CRNBC is aware of today's preposterously evil crime, which seriously threatens the health and safety of all nurses in BC (and elsewhere across Canada) and of Canada's entire population, it is hoped that CRNBC has the courage, confidence and resolve needed to act now to stop this, the most heinous, callous and heartless crime in human history! Please consider the following actions:

- Contact the CBC to apprize them and through them Canada's entire population, of this unthinkably cruel and pernicious crime that, unknowingly, is being perpetrated against them by corrupt and greedy industry-'captured' governments!
- Contact the federal government's Minister of Public Safety, the Honourable Ralph Goodale, apprizing him of your contact with the media, and DEMAND that he directs the RCMP to immediately launch an exhaustive criminal investigation of Canada's entire EMF / EMR community (which should include both the WHO and ICNIRP) in order to identify and apprehend those corrupt individuals responsible for this most heinous of all crimes ever committed against an unsuspecting, trusting and defenceless general population!
- Contact Prime Minister Trudeau and leaders of all main Opposition parties and DEMAND that all Government of Canada agencies and the R. Samuel McLaughlin Centre for Population Health Risk Assessment immediately sever their ties with the corrupt US M-I-C., and, instead, honor their mandates, which includes protecting the public's health and safety!
- Contact Canada's ministers of Health and (what used to be called) Industry Canada to DEMAND that their agencies immediately terminate their long-standing memberships in the corrupt US Military-controlled IEEE/ICES (Institute of Electrical and Electronics Engineers / International Committee on Electromagnetic Safety)!
- CRNBC should INSIST that Canada's entire scientific EMF / EMR community immediately sever ties with Dr. Art Thansandote, Health Canada's recently-retired EMR scientist, who continues to function (as he has done for at least the past 10 years) as Co-Chairman of ICES' Subcommittee 4, the very group who determine the

'safe' RF Exposure Limits for the USA (under the watchful eye of the US Military)!

- INSIST that Health Canada immediately and *publicly* recognizes '*non-thermal*' radiation (both Powerline Frequency 60 Hz EMF and RF EMR) and admit that, regardless of frequency, it **CAUSES** serious biological hazards to humans and all living things!
- DEMAND that Health Canada abandons ICNIRP's and the WHO's egregiously high 'safe' RF EMR standards and, instead, adhere to those recommended in the BioInitiative 2012 Report (which are 3-6 million times lower)!
- DEMAND that Health Canada, in divorcing itself from the US M-I-C, finally recognizes and makes allowances for those poor souls now suffering from EHS!
- DEMAND that Health Canada, henceforth, does not and will not permit ever again

 any new technology to enter the Canadian market that has not previously been
 tested (by qualified independent experts having no ties to industry) and proven to
 be biologically safe to humans of all ages, all sizes, and all levels of wellness, on a
 24/7/365 basis!
- Because BC's PHO and the Centre for Disease Control lack the necessary expertise to protect British Columbians from EMF / EMR and EHS, CRNBC must DEMAND that BC's government establish a formal consulting relationship with an independent, world-class EMF EMR expert who can be available, when required, to provide counsel to BC's medical community!
- CRNBC should consider suggesting to other provinces / territories in Canada that, in order to prevent today's tragedy from recurring, they should each consider establishing a formal liaison with a respected world-class radiation expert (preferably one based in Canada) who can readily advise on all EMF, EMR and EHS matters.
- Pressure B.C.'s Government to provide, to each of its five Regional Health Authorities, two radiation detection meters, i.e. 1) a trifield Gauss meter (one capable of measuring, separately, electric or magnetic fields) and, 2) an RF meter (one capable of detecting EMR in the frequency range not lower than 200 MHz (Mega Hertz) up to at least 8 GHz and preferably 10 GHz (Giga Hertz). (Suitable meters for both ELF and RF can easily be purchased on-line for a total cost of less than \$600, possibly closer to \$500.) (Given their modest cost, each and every medical facility in the province should be equipped with similar meters.)
- DEMAND that all governments in BC remove and replace, as quickly as is practicable, all wireless technology – especially 'smart' meters and Wi-Fi routers -

from all healthcare facilities, schools and homes, etc.! 'Smart' meters should be replaced with analogue meters; Wi-Fi routers should be replaced with hard-wired routers, preferably using fibre-optic cable; cordless phones should be replaced with landline phones!

- DEMAND BC's government to direct all telecom companies in the province to relocate their cell phone towers to safer distances from hospitals, schools, residential areas, etc. In doing so, all cell tower owners should be directed to reduce the 'effective radiated power' (ERP) of all towers to comply with the ALARA principle: As Low As Reasonably Achievable.
- Using a Gaussmeter (which are simple to use/read), CRNBC should ASSESS all electrical equipment / apparatus currently in healthcare facilities, to ensure that each is situated at a 'safe' distance from healthcare workers, patients and visitors.
- Using an RF meter (which simultaneously produces both audible and visual indications of radiation), CRNBC should ASSESS how much cancer-CAUSING non-thermal EMF/EMR is in each work space – in all facilities.
- Absolutely DEMAND that the Government of B.C. immediately block BC Hydro's current proposal (which, tragically, has been approved by an ill-informed Vancouver Parks Board) to install an underground electric substation in downtown Vancouver above which BC Hydro intends to build a new school to replace the existing older one which is to be demolished. BC Hydro's own President and COO volunteered that the new substation will produce magnetic fields of **30 mG!** (Clearly, even he is unaware that independent scientists say that magnetic fields should not exceed even **1 mG!**)
- DEMAND that, until and unless "5G" (Fifth Generation) technology can be tested (by independent, qualified health experts having no ties to industry) and proven to be biologically safe to people, that it will be banned from Canada! [26] [27]

For CRNBC's information, two of Canada's best known, world-class EMF / EMR scientists are Dr. Anthony Miller, professor emeritus (epidemiology), at the University of Toronto, and Dr. Magda Havas, Associate Professor of Environmental and Resource studies at Trent University, Peterborough, Ontario, either of whom should be able to critique what has been said here and/or advise you on any aspect of this truly despicable issue!
