**Subject:** Scientists say that non-thermal radiation is causing today's disease epidemics and innumerable premature deaths - but Health Canada refuses to listen!

**Extremely Low (Powerline 60 Hz) Frequency (ELF) Electro-Magnetic Fields (EMF)s and  
Radio Frequency (RF) Electromagnetic Radiation (EMR)**

With all due respect, please note that you, like all health care authorities in Canada (not just in BC), have been and are being duped about the alleged 'safety' of these subject man-made technologies! Non-industry scientists, globally, say that they both **CAUSE** (albeit not solely) autism, ADHD, leukemia and all forms of cancer (breast, thyroid, pancreatic, prostate, testicular, etc.), suicides, depression, miscarriages, Alzheimer's, Parkinson's, Sudden-Infant-Death-Syndrome, ALS, cardiac problems, asthma, etc.! Explanation. In this context, there are two kinds of non-ionizing radiation: a) thermal – that which heats the skin, which the body can detect and sense; and, b) non-thermal – that which the body cannot detect or sense, but which, scientists say, today threatens all life on earth – not just people! Non-industry scientists, globally, say that non-thermal radiation is emitted / produced by overhead power transmission and distribution lines, substations, power transformers, household electricity, electrical appliances, power tools and electrical machinery and electric vehicles, etc.! It is also emitted / produced by all wireless products, such as smart meters, smart appliances, cell phones, cordless phones, cell phone towers, Wi-Fi routers, Wi-Fi and Wi-MAX zones, Bluetooth devices, tablet and laptop computers, wireless keyboards and mice/mouses, vehicle collision avoidance systems, driverless vehicles, AM/FM radio and TV towers, radars, HAM radio towers, CB radio towers, satellites (military, scientific and commercial), etc.

Like every hospital in B.C., North Island Hospital Comox Valley campus (hereafter called 'your hospital') naively promotes to the public that it has 'Free Wi-Fi'! Your hospital even has Wi-Fi in your **cancer clinic**, which also allows cell phones, cordless phones, Wi-Fi routers, Bluetooth devices, tablet and laptop computers, wireless mice/mouses, etc.! And you, personally, along with your entire medical staff, all of your administrative and hospital staff - plus all of your patients - are being continuously bathed in hazardous man-made ELF EMF and pulsed RF EMR 24/7/365 days a week - in perpetuity! To learn how

this preposterous situation evolved, who is responsible, and why it is happening – in all Western countries - see below! [5] [6] [7] Yet no one cries out in dismay and anger that cancer is now the leading cause of death from disease in children? Or that the incidence of autism in the USA in 2016 was a frightening 1 in 36 for children and just 1 in 28 boys for boys! Why aren't people in the streets demanding answers? Perhaps it is because the public don't realize what is happening? Here are some facts:

- Mainstream news media made the decision some 50+ years ago to remain silent on this whole hazardous 'non-thermal' radiation subject! [8]
- In the 1960s, Health Canada's Radiation Protection Bureau's (RPB)'s elected to join the corrupt U.S. Military-Industrial-Complex (US M-I-C), which U.S. President Dwight D. Eisenhower warned the American people in 1961 to be on guard against. [9]
- In 1979, Health Canada's initial Safety Code 6: a) omitted any mention of ELF (power line 60 Hz) EMFs! b) omitted any mention of the known hazardous non-thermal effects to RF EMR; and, c) omitted any mention of the debilitating illness called 'Electro-Hypersensitivity' (EHS), which was first identified by German scientists in 1932! and, d) established for Canada the 'safe' RF EMR Exposure Limits – which was virtually the same as those of the U.S. military)! [10] [11]
- The infamous scientist, Dr. Michael Repacholi, a former head of Health Canada's RPB, not only established Canada's initial Safety Code 6 'safe' Exposure Limits for RF EMR, but he did the same thing for ICNIRP (International Commission on Non-Ionizing Radiation Protection) - which he helped to create, becoming its inaugural chairman and for which he is now chairman emeritus! Then he orchestrated things such that the WHO also had the same 'safe' RF EMR Exposure Limits! It is important for readers to note that Health Canada, the WHO and ICNIRP all now shared similar 'safe' Exposure Limits for RF EMR with the U.S. military (whose standards were determined by ICES (International Committee on Electromagnetic Safety), a committee within IEEE (Institute of Electrical and Electronics Engineers) – none of which will acknowledge that there are hazardous health effects from non-thermal RF EMR! [12] \_
- On June 3, 2010, BC's Government implemented the Clean Energy Act, making it mandatory for every occupied building in the province to be fitted with a smart meter – the 'industry-captured' government then allowed electric power utilities to choose the hazardous wireless option!
- On May 31, 2011, the WHO's International Agency for Research on Cancer classified RF EMR a Class 2B ("Possible) carcinogen! Informed people expected that this would cause Health Canada to either: a) to direct provinces to halt any further roll-out of smart meters and replace those already installed with safe analogue meters; or, b) to at least invoke the Precautionary Principle nationally in order to protect Canada's population! [13] [14] But Health Canada did neither.
- On June 29, 2011 – Less than one month after IARC had classified RF EMR a "Possible" carcinogen, BC's government signed a 10-year, \$100 million/year contract with Telus for the latter to upgrade provincial telecommunications in the province – landline and wireless. The contract specifically included all 5 Regional Health Authorities plus the First Nations Health Authority!

Note: British Columbia, like every province and territory in Canada, has no resident ELF EMF / RF EMR expert to question, challenge or even reject any pronouncement or decision that Health

Canada might make on EMF/EMR or EHS issues! Even BC's PHO and its Centre for Disease Control are incapable of protecting British Columbians from this man-made radiation!

For this reason, British Columbians, like people in every jurisdiction in Canada, are at the sole mercy of profit-focused electric power utilities and wireless and telecom companies, whose technologies are defended by the corrupt RPB within Health Canada! Tragically, the victims of this corruption are the unsuspecting, defenceless public, who increasingly pay a heavy and terrible price! For instance:

- Electric power utilities are able – and have been since 2010 – to install wireless smart meters on all occupied buildings in the province, callously ignoring people's expressed pleas to be exempted and/or written certification from medical doctors who have asked that their patients' be exempted on legitimate medical grounds even those who have heart pacemakers!
- Telephone companies are able – and always have been – to install extremely profitable but hazardous wireless devices wherever they feel so inclined - even in cancer clinics, hospitals, schools, government buildings, BC Ferries, etc.
- Telephone companies are also able to erect cell phone towers dangerously close to cancer clinics, hospitals, schools, residential communities, government buildings, etc. (North Island Hospital, Comox Valley campus is a classic example of where this has occurred!)
- Electric power utilities are able – and always have been - to install their overhead power lines, substations, power transformers dangerously close to cancer clinics, hospitals, nursing homes, schools, residential areas, etc. A current example of this can be seen in the City of Vancouver where BC Hydro has recently received approval to proceed with its proposed underground electric substation in a downtown public park - on top of which, once the substation is operational – BC Hydro will build an elementary school! BC Hydro's president and COO even admitted publicly that, when in operation, the substation will emit only **30-40 mG**, and, like their existing substations, will not emit more than **100 mG**, implying that even **30-40 mG** is extremely safe compared to that which Health Canada endorses – **2,000 mG!**

Important Note(s):

1. Health Canada and the WHO both say that the magnetic fields now present in homes, schools, places of work etc. are **SAFE**, and allows electric power utilities to say that **2,000 mG** (milli-Gauss) is safe for the public and **10,000 mG** is safe for workers! [15] [16]
2. Non-industry scientists, globally, say that a 'safe' ambient magnetic field should not be more than **1 mG!** [17]
3. Russian researchers say that a safe level should be **1,000<sup>th</sup> of 1 mG or 0.001 mG!** [18]
4. The average home in Israel has an ambient magnetic field of **0.45 mG!** [19]
5. In 2005, the prime minister of Israel's suite of five offices had to be vacated when it was discovered that the ambient level of magnetic field in the offices was **20-30 mG** – which was 10 times higher than the allowable level! [20]

Unassailable evidence – which would not have happened had British Columbians, Canadians and North Americans a bona fide free press:

- As of 12 Sept. 2018, over 200 scientists and doctors from 35 countries have signed a declaration to officials of the European Commission (28 countries) demanding a moratorium on the increase of cell

antennas for planned 5G (fifth generation technology) expansion ... and urge the EU to halt 5G roll out! [21]

- The world's largest (\$28 million) study conducted by the USA'S National Toxicology Program (NTP) and the renowned Ramazzini Institute's study (which were two separate, totally independent studies) both confirmed the link between cell phone tower and cell phone EMR and cancer! [ ] Yet the corrupt ICNIRP concluded in Sept., 2018, that the results were "*inconclusive*"! [22] [23]
- Since 2015, over 240 world-class scientists from 41 countries have signed the International EMF Scientists Appeal addressed to the Secretary General of the UN, to all UN-member countries (approx. 194) and to the Director General of the WHO urging all world leaders to: "Protect mankind and wildlife from EMFs"! [24]
- The BioInitiative 2012 Report (which is considered by many scientists, globally, to be the unofficial bible of EMFs / EMR and EHS) concluded: 1) that powerline 60 Hz magnetic fields are a Human Carcinogen; 2) that Health Canada's Safety Code 6 'safe' Exposure Limits for those exposed to RF EMR needs to be reduced between 3-6 million times; and, 3) Safety Code 6's Exposure Limits (like those of the WHO, ICNIRP, IEEE and FCC) all need to be based on the biological (i.e., non-thermal) effects of EMR – not on the obsolete and 30 years out-of-date thermal effects by which they are determined today! (Because the report is almost 1480 pages, one needs only to read the CONCLUSIONS.) [25]
- In July, 1999, those attending the World Conference on Breast Cancer, Ottawa, Ontario, were told by New Zealand's globally-respected Dr. Neil Cherry, O.N.Z.M. , Associate Professor of Environmental Health (1946-2003) that EMR CAUSES cancer! [26] [27]

In conclusion, there can be no doubt that North Island Hospital, Comox Valley campus finds itself today having to contend with unprecedented corruption, the likes of which now literally threatens each and every person in the hospital – including the president, all physicians and medical staff, all administrative and operational staff, and all patients – current and future! Knowing this, as president and CEO of North Island Hospital, Comox Valley campus, in order for you to fulfill your hospital's mandate - which includes: to make people well again and to save lives - you must rid your entire hospital of every hazardous wireless device for which there is available a hard-wired alternative capable of doing a similar job equally well, if not better! You must also educate yourself about, and apprise your entire staff to, the feared dangers of 5G technology! Also, because there is no resident ELF EMF/RF EMR expert in British Columbia to assist you, on behalf of the North Island Hospital Comox Valley campus, you need to hire an internationally respected expert in this field to conduct a thorough audit of each and every department within your hospital and, on completion, provide you with an itemized report prioritizing the order in which wireless equipment exchanges should be made. Then, with the approval of the Board of Governors, you could begin the process of systematically replacing hazardous wireless devices with safe hard-wired alternatives! By doing so, your hospital will quickly become the template for other hospitals in the province (and elsewhere) to follow. By maintaining and enforcing a wireless-free policy, your hospital should soon expect to see tangible results, e.g., your hospital should be better able to satisfy its mandate; your bed turn-over rate should be higher; your staff turn-over rate should be lower; your staff absentee rate should be lower; your operating costs should be lower; your morale rate should be higher - in all departments, also in patients; you should experience a significant reduction in the number of sick days taken by your hospital medical, administrative and operating staff, etc.! In a twisted, perverse way, Fate has been kind to North Island Hospital, Comox Valley campus, in that, being a new hospital, you are

presented with this ‘once-in-a-lifetime’ opportunity to be the catalyst to stop this insane and unthinkably evil corruption which now literally threatens all life on earth – including the heartless, greedy perpetrators!
