- In 1953, the US Navy had *Dr. Herman P. Schwan* determine for them their first-ever 'safe' Exposure Limit for those exposed to microwave EMFs which he did, based **ONLY** on the <u>thermal</u> effects! In doing so, he also set the 'safe' Exposure Limit at an outrageously high **10 mW/cm²**! This limit enabled the navy to operate its high-powered radars at maximum power (see entries for 1966 and 1979, below)!
- In 1965, the US Air Force and US Army adopted the US Navy's dangerously-high 10 mW/cm² 'safe' Exposure Limit for microwave EMFs and its <u>thermal effects ONLY</u> dogma!
- In 1966, all Five-Eyes member nations (USA, UK, Canada, Australia, New Zealand) also adopted the US Navy's dangerously-high **10 mW/cm²** 'safe' Exposure Limit and its <u>thermal</u> <u>effects ONLY</u> dogma! It is no wonder that any/all of today's civilian telecommunications products (including cell phone towers) easily 'COMPLY' with FCC 'standards'!
- In 1979, the infamous scientist, *Dr. Michael Repacholi*, set Health Canada's initial Safety Code 6 'guidelines' for RF EMFs, which proved to be similar to those of the US Navy: 10 mW/cm² as the 'safe' Exposure Limit and recognized ONLY the thermal effects of RF EMFs! While at the WHO, he played a key role there in not only creating what is known today as a corrupt and industry-friendly "ICNIRP" (International Commission on Non-Ionizing Radiation Protection) but he also played a major part in setting 'safe' Exposure Limits for RF EMF, not just for ICNIRP, but also for the WHO. Unbelievably, this one corrupt scientist, **Dr. Michael Repacholi**, played a major role in setting the 'safe' Exposure Limits for RF EMFs for all three agencies: Health Canada, ICNIRP and the WHO, all three of which now had guidelines similar to those of the US Military ... and all "Five-Eyes" member

June 30, 2011 – This marked the end of democracy in BC. - Contrary to what Health Canada states on its website, Safety Code 6 protects <u>only</u> against the <u>thermal</u> effects of RF EMFs!
