## **North American and Other Defenders and Champions**

(At least five of the names noted by European reporters are mentioned here as well):

#### Health Canada Scientists

Former and current EMF scientists include:

Drs. <u>Maria Stuchly</u>, conflicted <u>Daniel Krewski</u>, <u>Michael Repacholi</u> (an ICES member and chairman emeritus of ICNIRP, and is now an industry consultant), <u>James McNamee</u> (an ICES member), <u>Art Thansandote</u> (although he retired from Health Canada as their senior EMF scientist in 2015, he still is and has been for more than 10 years Co-Chairman of ICES' sub-committee 4, which determines for the US Military and the USA 'safe' Exposure Limits for RF in frequencies 3 kHz-300 GHz)\_and Pascale Bellier.

## BC Cancer Agency Scientist

Mary McBride (who was exposed by Canada's largest commercial TV network, CTV, when it found her not to be a qualified "PhD" or the "Dr." she had allowed others to address her or to call and/or refer to her as, as she had done for so many years). Her studies have consistently found in favor of there being no harmful effects to either ELF EMFs or RF EMR. [19] [20]

## • Other Extremely Influential Canadian Champions – but Non-Scientists

## • BC's current Provincial Health Officers (PHO)
