If the Public Only Knew The Truth
That 'Industry-Captured' Governments are Harming and Killing the Public!

Here are some facts, which informed people know:

- Scientists, globally, and the major militaries of the world, have known for many decades that residential electricity (power-line frequency [50 Hz/60 Hz] electro-magnetic fields [EMFs]) and pulsed radio / microwave frequency (RF) electro-magnetic radiation (EMR) **CAUSE** (albeit not solely) leukemia and many other forms of cancers, autism, ADHD, Alzheimer's, Parkinson's, miscarriages, stillbirths, suicides, depression, asthma, cardiac problems, Tinnitus, ALS (Lou Gehrig's Disease), SIDS (Sudden-Infant-Death-Syndrome), etc.;
- Residential 50 Hz/60 Hz EMFs and RF EMR both emit hazardous **NON**-thermal radiation, which is invisible, silent, odorless and tasteless; humans can neither sense nor detect it;
- The latency of most cancers and other serious diseases is at least 10 years and can be 30 years or even longer, depending on a person's lifestyle, living environment and overall exposure to EMFs/EMR; (Non-Hodgkin lymphoma nearly claimed my life some 25 years after I had foolishly and naively adopted all contemporary electricity-based technology.)
- Mainstream news media controls (determines) what the public is allowed to see/hear/read about the dangers of **NON**-thermal power-Line EMFs and pulsed RF EMR;
- The cancer industry world-wide virtually never mentions EMFs / EMR when discussing possible causes of cancer;
- Mainstream news media controls (decides) what the public is allowed to see/hear/read about the countless lawsuits launched in many countries of the world by people who claim that their or their loved one's health suffers or suffered because of **NON**-thermal EMFs/EMR;
- EMFs and EMR - from all sources, on all frequencies - adds up or thickens, much as smoke thickens in a room as more people smoking different devices enter the room;
- What "5G" (fifth generation) technology really entails, and that no man, woman or child - and no living thing - can possibly escape the hazardous pulsed **NON**-thermal microwave radiation (RF EMR) that will be emitted **simultaneously** by some 20,000 low orbiting satellites and an estimated 13-million microcell towers in the U.S. alone (placed in front of every 2nd to 10th home in every community in the U.S.A.). (Note: The public needs to realize that the microwave frequencies to be used in 5G technology have not only never been tested and proven to be safe for humans, but are known to be some of the same frequencies used by the U.S. and other major militaries of the world to control and/or disperse crowds. These frequencies are **electronic warfare weapons**; and,
- All of the above incalculable amount of hazardous microwave radiation simply adds to the previous unfathomable amount of man-made EMFs/EMR (which the WHO calls 'electro-smog') that has already been emitted by man's earlier 2G (2nd generation), 3G and 4G technologies!

Knowing the above, people understandably ask: Why would governments, especially those that claim to be "democratic" governments, allow industry to do this to an unsuspecting, defenseless public – when it is known that even the perpetrators themselves can't escape this radiation? Is this some monstrously-insane macabre plot to reduce planet Earth's population? If not, what other reason can there be to explain how/why Western governments are deaf and blind to today's enormous and ever-growing list of disease epidemics and premature deaths?

History

In all industrialized countries of the world, people and communities depend on electricity. Without residential electricity there could be no electrical appliances, machinery, tools, electronic or telecom products. Today, governments, electric power utilities, telecom and electronics companies all make huge profits from the sale of man-made electricity-dependent products. National governments earn still more billions of dollars by auctioning off the frequencies all wireless radio products need to 'operate' on! The public also need to realize that mainstream news media (especially television) skillfully influences and is highly successful at manipulating what people think and believe to be true! But, because of governments' technological ignorance, naïveté and/or government / corporate greed, none of them tell the public about the KNOWN dangers of electricity and wireless radio products – both of which emit hazardous radiation (explained below). Tragically and criminally, increasingly more people are becoming sick and die prematurely, often without anyone knowing what caused their illness or death. Informed people know that, with any form of radiation, distance is your friend, i.e., the further one is from anything that emits radiation, the safer one is.

Frequencies. To understand the importance of "frequencies" readers need to understand that, although not all schools teach it, scientists know that people – like all living things - are bio-electrical beings, meaning that each of us functions on extremely minute electrical impulses generated by our heart and/or brain (which is why doctors send us for an ECG or EEG assessment, respectively). Human brains generally function on frequencies in the range 0 Hz to 40 Hz, but also use frequencies which are much higher. Household electricity is provided to our homes and communities on frequencies of either 50 Hz or 60 Hz ("Hz" means "Hertz," which previously had been called "CPS" or cycles per second). The major militaries of the world have long known that man-made frequencies, especially when pulsed, can easily interfere with, damage, entrain or completely destroy nature's exquisitely delicate electrical signals (frequencies).

Canada's military was (and still is) a member of the 'Five-Eyes' intelligence-gathering community (led by the U.S. Military whose other members include their military counterparts in the U.K., Canada, Australia and New Zealand), all of whom, shamefully, elected in 1966 to adopt the 'safe' Exposure Limits for radio / microwave frequency (RF) radiation that had previously been established for the U.S. Navy in **1953**. It is important to note that these 'standards' were based solely on the thermal (heating) effects of electromagnetic field (EMF) radiation! This decision, while it proved to be an unprecedented bonanza for the profit-driven electric power generation industry, and created a whole new universe of highly-profitable manufacturing opportunities for the then nascent wireless and telecom companies, has cost the unsuspecting and defenseless public dearly, not just in Canada but in all Five-Eyes countries, as they too have become flooded with extremely profitable man-made electrical and electronic technology, all of which emit hazardous but invisible **NON**-thermal radiation. Contrary to what Health Canada and the other two equally corrupt international regulatory agencies: the WHO (World Health Organization) and ICNIRP (International Commission on Non-Ionizing Radiation Protection) say, non-industry scientists and the major militaries of the world (communist and democratic) have known for decades that **NON**-thermal radiation CAUSES most of today's disease epidemics (albeit not solely). This explains why most if not all schools today require special-needs' teachers! Tragically for mankind, Canada's authorities (like

their allies) are obliged to vigorously defend the decision Canada made in 1966, for fear of now being imprisoned, face crippling class-action litigation and/or financial ruin.

Contrary to what Health Canada's Radiation Protection Bureau' would have the public believe, non-industry scientists, globally, know that the **NON**-thermal effects of EMF radiation (both Power Line frequency {50 Hz/60 Hz} and the *pulsed* RF EMFs) have been studied far more extensively, for much longer periods of time, and are far better understood than tobacco ever was, which the WHO finally named: "the world's single greatest preventable cause of death in 2008"! But today, Health Canada (like its corrupt allies) is obliged to stubbornly defend, protect and promote the thermal effects ONLY dogma as these industries depend on this lie being perpetuated!

Extremely Low Frequency (Power Line 50 Hz/60 Hz) EMFs

In the late 1800s, residential electricity was introduced into urban America and gradually made its way across the nation. As Dr. Sam Milham, MD, MPH (a world-class epidemiologist) wrote in his book: "*Dirty Electricity – Electrification and the Diseases of Civilization*," the life expectancy of urban city dwellers was approximately 50 years of age; whereas those who had not yet received electricity (and the Amish people, who shun electricity) lived to be in their 70s! That alone is very telling. Readers are also encouraged to read: "*The Great Power-Line Cover-Up – How the Utilities and the Government are Trying to Hide the Cancer Hazards Posed by Electromagnetic Fields*" by award winning American investigative journalist, Paul Brodeur.

A brief sampling of historical events which should have prompted any decent, democratic government to act in order to protect the safety and health of its people, include:

- Since at least 1979, non-industry scientists have known that an ambient level of magnetic field in a home or school should not be higher than 1 mG (i.e., one, one-thousandth of a Gauss) yet Health Canada makes absolutely no mention of "Power Line EMFs" in its globally-vilified Safety Code 6 – thereby allowing the public to believe that power line EMFs are perfectly SAFE, when they are anything but!
- A 2002 study of 1,000 American homes showed that the average home in the U.S. had an ambient magnetic field of less than 1 mG, yet this was and is ignored by the Governments of Canada and the U.S.A.
- The governments of Canada and the U.S.A. also chose/choose to ignore that, in 2005, Israel's Prime Minister's suite of five offices had to be vacated when a magnetic field of 20-30 mG was discovered (which is 10X more than the allowable limit)! Knowing this, how is it possible for the Government of Canada, the Government of BC, and the City of Vancouver to allow BC Hydro to build an underground electrical substation in a downtown City of Vancouver public park, which the Pres/COO of BC Hydro publicly volunteered will emit magnetic fields of less than 100 mG (implying that this level is extremely safe, given that Health Canada allows the public to be exposed to magnetic fields of up to 2,000 mG)! Inconceivably, when finished, BC Hydro is authorized to then build on top of the substation a new elementary school! <https://www.bchydro.com/content/dam/BCHydro/customer-portal/documents/projects/west-end-substation/bch-open-house-story-boards-april-2018.pdf>
- The BioInitiative Reports (2007, 2012 and 2017) the last two of which had 29 authors including 21 PhDs and 10 medical degrees from ten different countries concluded that 'safe' ambient levels of

magnetic field should not exceed even 1 mG in homes or schools! They also concluded that EMR CAUSES cancers and other diseases of the central nervous system, although not exclusively.

- In 2005, the notoriously corrupt Dr. Michael Repacholi, assisted by the eight (8) electric utility representatives he had invited to help him, established - for the world (minus the USA) - today's astronomically-high 'safe' Exposure Limits for both electric and magnetic fields for Power Line frequencies. These now 'legal' but dangerously-high 'safe' levels of magnetic field, enable electric utilities to build their power transmission and distribution lines, electrical substations, power transformers dangerously close to schools, homes, hospitals, communities, etc. In turn, this saves electric utilities literally billions of dollars in real estate costs they otherwise would have to spend to buy the additional land necessary for them to distance their infrastructure further (at SAFER) distances from the public!
- As was stated above, even though Health Canada's Safety Code 6 does not cover power line frequencies, the Government of Canada and the WHO publicly endorse the outrageously high 2000 mG recommended for the Public by Health Canada's own former head EMR scientist, Dr. Michael Repacholi (who, after leaving Health Canada, became Chairman of the corrupt ICNIRP), who, on behalf of ICNIRP, said that Workers can be 'safely' exposed to magnetic fields of up to 10,000 mG.
- To this day, Health Canada continues as a key member of this corrupt cabal even though in the U.S.A., the civilian - but military-controlled ICES (International Committee on Electromagnetic Safety) - and the U.S. FCC (Federal Communications Commission) recommend that the Public can be safely exposed to 9,040 mG and Workers up to 27,100 mG!

It is important for readers to note that in the U.S., responsibility for setting 'safe' radiation limits historically had been assigned to the EPA (Environmental Protection Agency) who employed numerous qualified EMF / EMR scientists. That all changed in 1996 when the EPA was specifically directed not to conduct any further research into the hazards of EMFs/EMR, and their responsibility for setting 'safe' Exposure Limits was stripped from them and given to the FCC, which is widely known to be a 'captured' agency (i.e. captured by the very industries it is supposed to regulate). All five commissioners of the FCC are appointed by the President of the U.S.A. Both its current and previous Chairman were/are known to be extremely aggressive industry promoters.

- Tragically for Canada's population, ISEDC (Innovation Science and Economic Development - previously called Industry Canada) operates in lock-step with the FCC; it too is corrupt and preaches the 'thermal effects ONLY' dogma.
- Health Canada allows electric power generation utilities to build overhead high voltage power lines dangerously close to residential communities (e.g. Nile Creek, near Bowser, on Vancouver Island, B.C., which has **twin** overhead 525 kV power lines within 100 feet of the nearest home.) (This is just another example of how electric power utilities are permitted to save billions of dollars while showing absolutely no regard for the public's safety and health.)

Radio / Microwave Frequency EMFs

Between 1961 and 2014, the U.S. White House Administrations of six Presidents: Eisenhower, Kennedy, Johnson, Nixon, Clinton and Obama, and U.S. Senator John McCain all gave indications which, when taken collectively, made it clear that there was widespread corruption and an incestuous relationship between the U.S. military, government and industry. For example, in 1968, U.S. President Lyndon B.

Johnson pledged: “To keep Americans safe in their homes and at work” and to “protect them from the hazardous radiation from TV sets and other electronic equipment.”

A sampling of other historical events which should have prompted any decent, democratic government to act in order to protect the safety and health of its citizens, include:

- Because U.S. EMF scientists had openly snubbed and dismissed Soviet EMF scientists in the early 1950s, as if the latter’s science was inferior (even though Soviet scientists had long known that there were both thermal and **NON**-thermal effects to RF EMF and wanted a meeting so that both nations could compare and exchange scientific knowledge), the Soviets deliberately irradiated the U.S. Embassy in Moscow throughout the period 1953-1976 with pulsed **NON**-thermal microwave radiation. They did so for just six hours a day, five days a week. Even so, during that 23-year period, three U.S. Ambassadors died of cancer; at least 16 women contracted breast cancer, while many Embassy employees suffered various other diseases. Records show that the Soviets used similar frequencies and, at times, even less power than is used in some of today’s extremely profitable wireless products. Shamefully, although the U.S. Government became aware of this, they withheld telling their own Embassy staff for at least 10 years while they observed the effects of the pulsed **NON**-thermal radiation on their own people.
- As was previously stated, America’s initial ‘safe; Exposure Limits for RF EMFs were set for the U.S. Navy in 1953 - based solely on the heating or thermal effects of RF EMFs! These outrageously-high ‘safe’ Exposure Limits still allowed the navy to continue operating its powerful long range radars at maximum power.
- In 1966, the above “thermal effects ONLY” standards – and the extremely-high ‘safe’ Exposure Limits were also adopted by America’s industry and by all ‘Five-Eyes’ member countries, including Canada.
- In 1990, the U.S. EPA wanted the U.S. Government to classify EMFs a “Probable” carcinogen, but industry lobbyists won out.
- In 1996, German scientists warned mankind about the dangers of non-thermal EMR!
- In 1999, at the World Conference on Breast Cancer, in Ottawa, Canada, the guest speaker, Dr. Neil Cherry, ONZ, of New Zealand (now deceased), told the audience that EMFs CAUSE breast cancer!
- Since at least 2001, the world’s largest insurance companies (Lloyd’s of London and Swiss Re) have refused to provide liability insurance (against health claims) for any product or device that emits EMFs (which includes EMR)!
- Neither Health Canada nor ISEDC shows any concern that the U.S. Military identified frequencies between 1 GHz and 5 GHz as being the most harmful to humans, as these frequencies penetrate all organ systems of the body and thus put all organs at risk. This band of frequencies is precisely where ISEDC has authorized all of today’s wireless devices – even baby monitors and smart meters - to emit their hazardous pulsed **NON**-thermal microwave radiation! (My own email letters in which I advised both agencies of this went unanswered.)

- Health Canada also does not want the Canadian public to know that in the U.S.A. the cell phone industry sued the City of San Francisco, in 2010, and the City of Berkeley, C.A., in 2015, to prevent them from passing ordinances that would have compelled cell phone retailers in those cities to

provide purchasers with information advising them that all cell phones emit microwave radiation, some more so than others, and informing buyers that mobile phones should not be held against the body, nor kept in pant pockets, and warning women not to keep them in their bras. Although San Francisco caved-in (the cell phone industry threatened to withdraw all its convention business from San Francisco and give it to another city), but the City of Berkeley won. When the cell phone industry appealed the decision to the California's Supreme Court, it lost again!

- No wireless product / device or gadget has ever been made to undergo independent testing by qualified experts having no ties to industry to **PROVE** that it is safe to be used by, on and around people of all ages, of all sizes, of all levels of wellness 24/7/365 in perpetuity – not even baby monitors and definitely not smart meters!
- No CEO of any electric power generation utility, wireless or telecom company dares to state unequivocally, in writing, that their technology is/are safe to the general population.
- Not once has Health Canada ever invoked the “Precautionary Principle” in order to protect the public. In part, this would have put the onus on **Industry** to prove that their technology is truly safe! Instead, Health Canada has – and still does – put the onus on the **Public** to prove that industry's technology is **NOT** safe!
- Health Canada allows TV stations across Canada to run dishonest and grossly misleading ads that show only the glamorous side of wireless technology, featuring happy, healthy people cheerfully holding cell phones to their heads; people cheerfully cavorting and holding / using laptop computers on their laps; happy, healthy people with laptop computers in bathtubs; cell phone towers emitting radiation that slants only upwards and disappears safely into the stratosphere, rather than showing its factual trajectory which is downwards where it bathes, not just people with wireless products / devices, but every living thing - in all directions!
- Nor does Canada's government inform/advise/warn the public that all cell phones manufacturers warn the public not to hold cell phones against the head or body, not to carry the phone in a pants pocket, and for ladies not to store cell phones in their bras; although the unsuspecting public are generally totally unaware that such warnings even exist in the fine print of their cell phones.
- In 2011, the WHO classified RF EMFs a Class 2B (“Possible” carcinogen), yet Health Canada did not see fit to halt electric power utilities from rolling out their wireless Smart meters, each of which has two microwave radio circuits that emit pulsed RF EMFs day and night; the more powerful of which spews invisible, silent, pulsed **NON**-thermal microwave radiation in all directions - for distances of up to 3 Km!
- Nor did the above WHO announcement cause Health Canada to immediately halt telecom companies from installing their extremely lucrative Wi-Fi routers, cell phones, cordless phones, Bluetooth devices, etc. (all of which emit hazardous pulsed **NON**-thermal EMR) in cancer clinics, hospitals, schools, government buildings, public transit systems, etc.
- Nor did the above WHO announcement cause Health Canada to halt telecom companies from erecting cell phone towers near schools, hospitals, communities, places of work, etc. (Again, cell towers all emit pulsed **NON**-thermal EMR - in all directions.)
- Again, it must be noted that just one person was instrumental in setting essentially the same so-called ‘safe’ Exposure Limits for RF EMFs for **all three agencies** (Health Canada, ICNIRP and the WHO) i.e., the former head of Health Canada's Radiation Protection Bureau: the unconscionably corrupt Dr. Michael Repacholi.

- Nor did the Canadian - or any Five-Eyes - government react as they should have in response to the findings of either 2018 study: 1) the renowned Ramazzini Institute Study, in Italy, of cell phone towers; and, 2) the 'gold-standard,' 10-year, \$30-million NTP (National Toxicology Program) study of cell phones, done in the USA, both of which found similar clear evidence that EMR **CAUSES** cancer!

On a personal note, I underwent open-heart surgery in January of 2014, which left me with a heart pacemaker implanted in my chest. When we moved later that month from British Columbia's mainland to our present home on Vancouver Island, we found that we had a hazardous wireless smart meter on our new home. On March 5, 2014, I wrote and sent via Registered Mail a hand-written letter addressed to Mr. Charles Reid, then President and CEO of BC Hydro. In my letter, I explained to Mr. Reid that I had had cancer in 1973; that I was currently recovering from open-heart surgery, and told him of my pacemaker. I explained to him my training in and knowledge of Electronic Warfare and of my legitimate concern for anything that emitted pulsed microwave radiation, especially wireless smart meters. Instead of the responsible reply I expected, Mr. Reid saw fit to perfunctorily delegate my letter to one of his staff to answer. In her letter to me, Mr. Reid's employee ignored entirely all that I had said about my health and concerns, and instead simply threatened to **cut off our power** if we dared touch their smart meter!

Today's pandemic corruption is more than just palpable! It is so preposterous that sane, ordinary people simply cannot believe it! Nor can people comprehend that ANY government, let alone the Government of Canada (primarily Health Canada and ISEDC) can be so gutless, so callous, so terribly corrupt, and so completely entrenched with the U.S. Military-Industrial-Complex - which it has been since at least 1966. It is equally inconceivable to ordinary people that Canadian industry (electric power generation utilities and telecom companies) have absolutely no regard whatsoever for the public's health and safety (let alone for their own), and, instead, are focused only on making money – and on presumptively and arrogantly pushing an adversary's (China's) Huawei's extremely dangerous and life-ending 5G technology on all Canadians, as if it were absolutely imperative for us all to have it. Instead, history will show 5G technology to be the greatest single crime-**ever** committed against an unsuspecting and defenseless public – without either their knowledge or consent. While there is still time, Canadians need to familiarize themselves with the Business Council of Canada (formerly the Council of Canada's Chief Executives - Canada's most powerful lobby group) and see those members who are now indefensibly pushing Canada's adversary's (China's) Huawei's existential 5G technology. Clearly these executives know absolutely nothing about the hazards of EMF/EMR or they are completely blinded by the estimated \$13-trillion industry pundits estimate that 5G will generate.

Honest, responsible, sane governments of any political stripe could not / would not ignore:

- the hundreds of scientists and medical doctors, globally, who have appealed to all governments of the world to "Protect mankind and wildlife from electromagnetic field radiation and wireless technology," nor
- the more than 150 scientists from 37 countries who have recently urged all world governments to ban "5G" (fifth generation technology) from space and earth, etc., etc.
- Dr. Martin L. Pall, PhD, Professor Emeritus of Biochemistry and Basic Medical Sciences, Washington State University (one of the world's foremost scientists and authorities on 5G technology) is on record saying that: "If man does not stop 5G, he will not have to worry about Global Warming or

Climate Control.” Dr. Pall has a free online book on the dangers of 5G technology. How can educated men be so unbelievably stupid?

- In 2018, according to the U.S. Centre for Disease Control, the number one cause of death from disease of **children** aged 5 to 14 years of age was **cancer**! Is this not an unbelievable crime? Is this not justification for a national / international criminal investigation? This is definitely not the Canada I was born into in 1935, and it definitely is not a Canada of which I am proud. Those found to be guilty should be identified and punished accordingly.
