The hazardous radiation I'm referring to is emitted by man-made:

- Power line frequency (50/60 Hz) infrastructure and products, such as power transmission and distribution lines, electric substations, power transformers, smart meters, electrical circuit-breaker panels, smart appliances, many of today's consumer electronics (those with batteries that need to be re-charged using household current), etc. emit non-thermal electric fields and magnetic fields (EMFs); (*View the U.S. M-I-C Attachment to see what **U.S. President Richard Nixon's** own radiation Advisory Committee warned him about in 1971, years before wireless radio frequency (RF) products even appeared in North America.*)
- Radio Frequency (RF) are those frequencies between 20 kHz and 300 GHz (20 thousand to 300 billion Hertz) and include *microwave* frequencies 300 MHz to 300 GHz (300 MHz is 300 million Hertz). Wireless RF products emit pulsed, non-thermal EMFs, from products such as: smart phones, cordless phones, cell phone towers, baby monitors, Wi-Fi routers, smart meters, smart appliances, Wi-Fi and Wi-MAX zones, Bluetooth devices, desktop/tablet/laptop computers, security systems, remote control units, GPS and thousands of other military, commercial and scientific satellites now encircling the globe, etc.

It is critically important for municipal governments to realize that

technologically-ignorant, billionaire entrepreneur, Elon Musk (owner of SpaceX) already has received authority to launch 12,000 orbiting satellites, with which he/SpaceX plans to irradiate planet Earth with broadband Internet using 5G (fifth generation) technology. Municipal governments also need to realize that this new unbelievable downpour of radiation from space is to be matched by land-based telecommunications companies who have their own plans to irradiate every inch of space on planet Earth with their terrestrial-based version of 5G technology in order to provide everyone on earth (whether they want it or not) with access to broadband Internet. - Electric power utilities also save literally billions of dollars in real estate fees they too would have to spend were they to build their

infrastructure (power transmission and distribution lines, substations, power transformers, etc.) at safer distances from schools, homes, hospitals, places of work, residential communities, etc. Municipal governments need to note that non-industry EMF scientists, globally, say that a 'safe' ambient level of magnetic field in a home or school should not exceed even **1 mG** (i.e., one, one-thousandths of a Gauss) yet Health Canada endorses ICNIRP's (International Commission on Non-ionizing Radiation Protection) recommendation of **2,000 mG**, as does the equally corrupt WHO (World Health Organization). The corruption is even worse in the USA, where the Public can legally be exposed to magnetic fields of up to **9,040 mG** and Workers up to **27,100 mG**!
