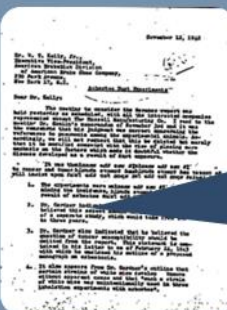

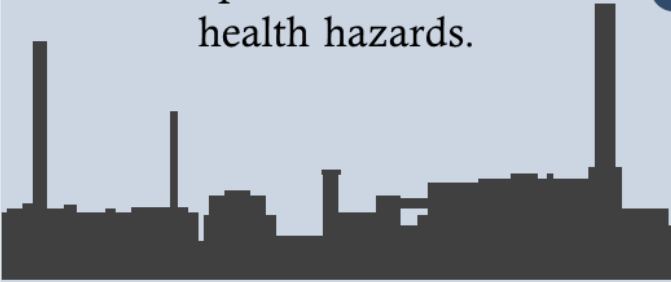

**1906**

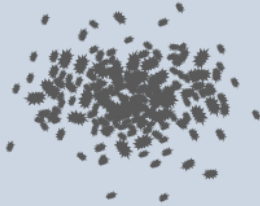
First proven case of asbestos death.

Researchers discover that asbestos causes Asbestosis.



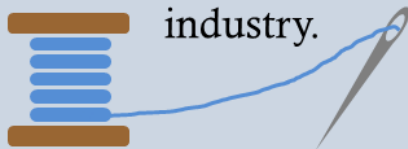
**1918**

US Bureau of Labor Statistics reports an unusually early death rate in asbestos workers.



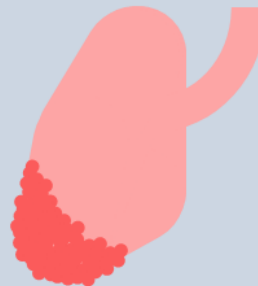
**1930**
