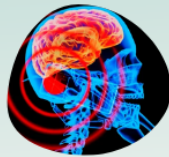

We demand the urgent reduction of exposure limits of electromagnetic radiation based on hundreds of current scientific studies.

Context:

The WHO has adopted limits suggested by the ICNIRP (*International Commission on Non-Ionizing Radiation Protection*) that are based only on **short-term effects** (thermal effects), which do not correspond to the current profile of **long-term** use of technologies, for example, radio base stations, wireless routers, smartphones, smartwatches, tablets, notebooks, bluetooth, etc. Several important appeals, resolutions, studies and articles have been issued, in recent years, by the scientific community alerting public health authorities about the necessary reduction of exposure limits to low and high frequency electromagnetic fields.

Let's demand that WHO protects the health of the population!
