## Acupuncture Today Article Feb. 2022

In February of 2022, the journal Acupuncture Today published an excellent article by Kathy Veon, [“EMF Exposures: Adverse Effects on Patient Health and Outcomes.”](#)

Environmental Health Trust circulated her article in a March 2022 newsletter.

Kathy outlined many issues that are familiar to the community, including oxidative stress, cellular signaling, genetics, voltage gated calcium channels (VGCCs), mast cell activation, depletion of antioxidants including glutathione, inflammatory conditions, blood-brain barrier and cell damage, DNA breaks, and peroxynitrite, with references.

Kathy identified acupuncture points that can be used for EHS patients.

At the end of her article, she wrote about “Making Your Practice Safe”

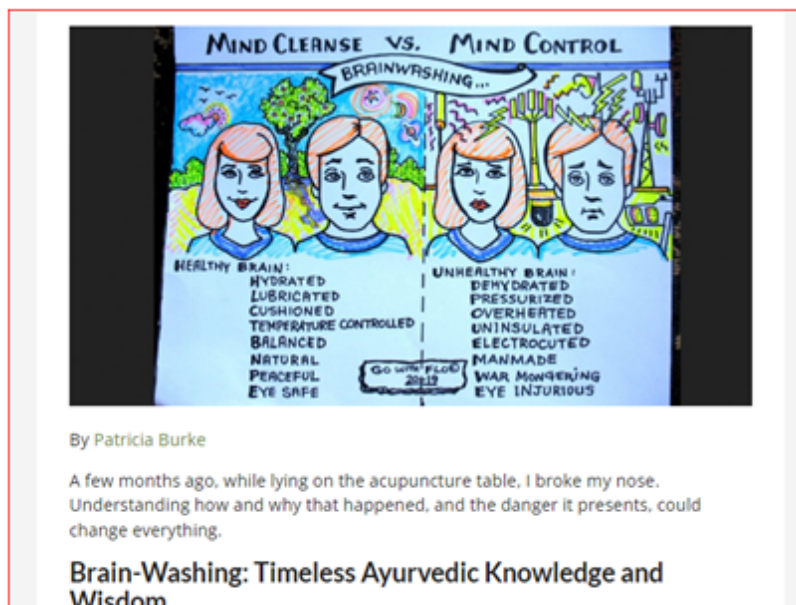
*“I have turned my treatment and consultation room into a Faraday cage by using professional remediation products to block all EMFs from entering the room. Patients must turn all wireless devices to “airplane mode” and turn off all antennas before*

entering. Many patients notice the difference and often comment on how "peaceful" and "good" it feels.

## Documented Acupuncture Injury Associated with Wireless Exposures

After Kathy published her article, I contacted her about an article I had written in 2019 for Natural Blaze about the fact that I was injured on the acupuncture table by an invasive wireless frequency.

# Brainwashing Vs. Brainwashing — Eastern And Western Worldviews And Wireless Woes



I was sound asleep on the table, which to me indicates a great treatment, when I was jolted awake by an artificial frequency that I often both hear and feel.

My heart was racing as I watched the needle from my right sinus point sail through the air. As the bones in my skull contracted in an attempt to protect my brain, the needle on the left side was caught, and driven deeper into my face. The force of the cranial bones contracting and meeting the immovable object of the needle broke the bridge of my nose. My chiropractor confirmed this narrative.

[Dr. Bill Maykel](#) and I had been working on bringing this information forward about EHS and skull contraction before he passed away in November of 2020.

As a lightning strike survivor, I am aware of the fact that the 26 cranial bones can contract to create a protective mechanical barrier around the brain. Western medicine does not yet recognize the expansion and contraction of the skull that accompanies respiration, believing that bones move as the result of muscular contractions alone. But cranial sacral therapists and chiropractors routinely reset the cranial respiratory movement.

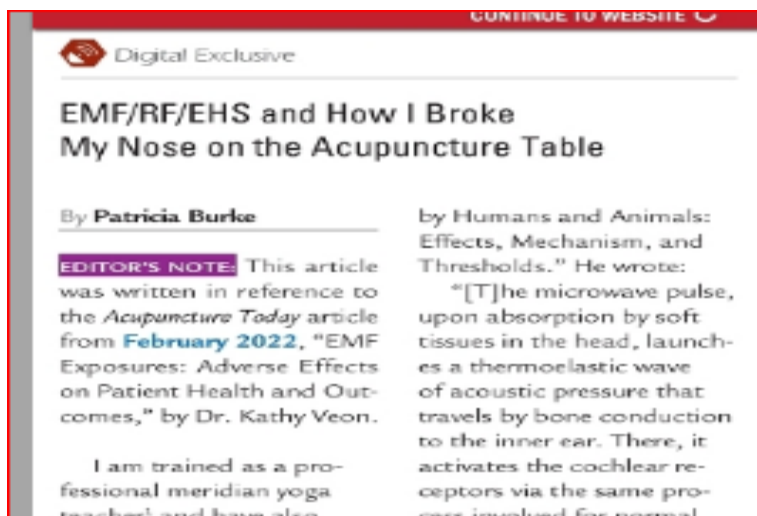

### Acupuncture Today Article Oct. 2022

Kathy Veon encouraged me to submit my story to Acupuncture Today, and I was very grateful when they asked to publish it.

Kathy had waited for a year for her article to run.

The editor contacted me in August and published in October.

I believe the editors understood the serious implications - that inharmonious frequencies can not only make a treatment ineffective, but can also cause harm, introducing liability and risk to practitioners and patients.

I have since learned that many EHS patients do not feel safe in acupuncture offices due to uncontrolled electro-pollution. Patients also find that they cannot hold their adjustments once they are exposed to RF again, rendering acupuncture treatment not worth the financial cost.

I was also surprised that a number of acupuncturists contacted me who are no longer practicing because they are sensitized to RF.

### **EHS/EMF/RF to be Discussed at Florida Acupuncture Licensing Board Meeting on Dec. 2, Open to the Public**

After my letter was published last month, Kathy Veon took both of our articles along with other materials about EHS to her state acupuncture licensing board in Florida.

She was able to place the topic of patient access and patient safety for the EHS population on the agenda for the state's board meeting, which will be held Friday, December 2 at 9 am EASTERN TIME.

The meeting will be held via the gotomeeting platform and is open to the public.

Kathy couldn't attend this call today, but she wrote:

*"I would love for anyone who is for us to attend the call in December. It is a public meeting and welcome for all to attend.*

*The supportive presence and force of positive energy and truth will be wonderful to have during the meeting.*

*There is always a designated space for 'public comment' which is open for anyone on the call. typically reserved for the end of the meeting, however, I may also ask for public comment during the discussion of materials about EMF / EHS, etc. So if anyone has a brief comment or voice of support, it would be wonderful to have people in attendance to do so.*

*I feel that this is an important time to take action, and the information presented will be very compelling and worthy of asking for and expecting positive action to address the safety, efficacy and reasonable access to medical care for all people."*

She also wrote:

*I want to push for rules that require acupuncturists to consider the environment in which they practice, and the need for EMF accommodation. I feel that acupuncturists are in a very unique position to ask for, require, demand changes in the proliferation*

*of 'mandated technology' which puts us all at risk for harm and excludes a large population from seeking medical care. I am hoping that this opens up the discussion / rule-making for all medical professions...*

### **Acupuncture Uniquely Concerned About RF/EMF**

Acupuncture often begins with the practitioner evaluating the energy in the twelve meridians, and then assessing how to balance the distribution of those energies. If the electromagnetic environment is not stable during the treatment, and/or the distribution of energy in the meridians is altered by uncontrolled external forces, the acupuncturist can't guarantee the effectiveness or safety of treatment.

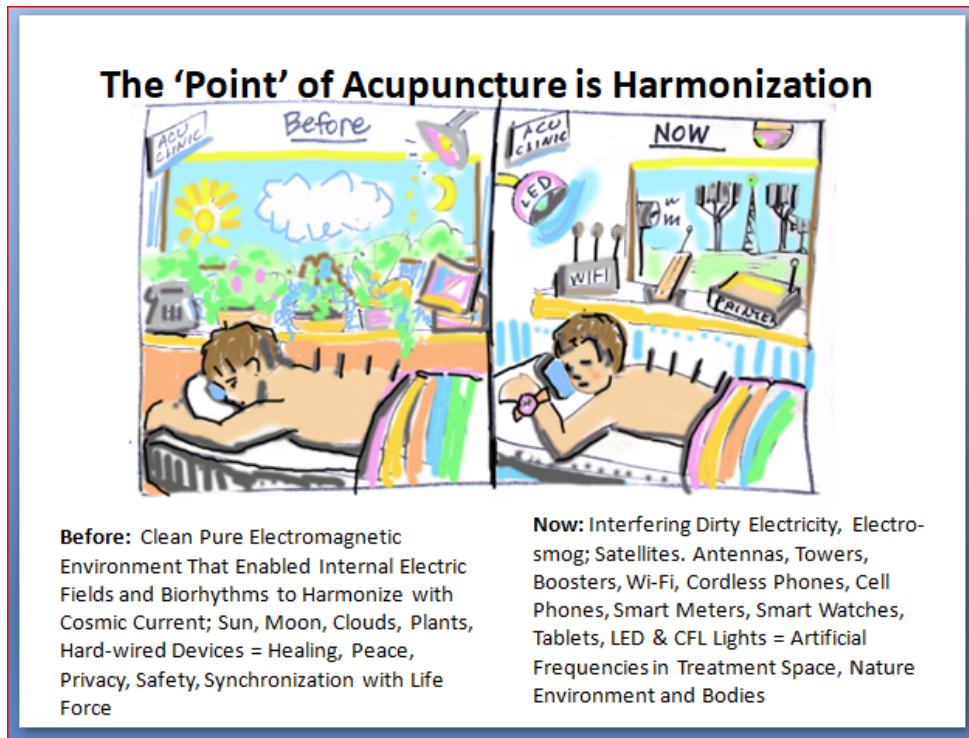
In addition, some acupuncturists use electrostim with needles, and/or place heating pads on treatment tables, most likely without recognition of dirty electricity and power quality issues.

There is a very real possibility that acupuncture needles may act as unintentional antennas.

### **Public Education and Outreach Efforts**

I wrote 3 additional articles this month about acupuncture and EHS published at Natural Blaze and Safe Tech International, one about electrical pollution from the grid and RF in offices, one about a training conducted by a Wisconsin acupuncturist about treating EHS, and one about the implications of the Law of Midday-Midnight and nighttime smart meter transmissions

Each of the articles builds on the concept that acupuncture treatments are designed to harmonize the inner environment with the rhythms of the natural outer electromagnetic environment.

We recognize this interrelationship when we experience jet lag.

As I wrote for Acupuncture Today, there is a historical precedent, where anesthesiologists and pediatricians confronted the practice of surgically removing tonsils in children.

The actions of one profession can bring an issue to the forefront.

Others have suggested reaching out to acupuncture training schools and the other state licensing boards. We are hoping we can build on our efforts after working in Florida.

Subsequent discussion:

(Acupuncturists have also mapped out different qualities in different areas of the skin that they use to harmonize internal energy fields. This is similar to research that indicates the sweat glands act as heliacal antennas. This knowledge codified in the East nullifies engineering models that claim that the skin is homogeneous.)
